RECITALS

- Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as findings of fact.
- Section 2. The Board of County Commissioners hereby accepts the Quit Claim Deed for part of the right-of-way required per the Concurrency and Impact Fee Credit Agreement for Alterra Partners, LLC., known as The Lakes at Mill Creek Plantation.
- Section 3. To the extent that there are typographical errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

Section 4. The Clerk is instructed to record the Quit Claim Deed in the Public Records of St. Johns County, Florida.




