WHEREAS, the County desires to enter into a contract with Tom Nehl Truck Company to purchase one (1) 2016 Roll-Off Truck for the purpose of providing replacement truck for the Road & Bridge Department; and

WHEREAS, through the County's formal bid process, Tom Nehl Truck Company was selected as the most qualified respondent to enter into a contract with the County for the purpose referenced above; and

WHEREAS, the project is being funded by the Road & Bridge Department; and

WHEREAS, said purchase serves a public purpose.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.

Section 2. The County Administrator, or his designee, is hereby authorized to award Bid No. 16-33 to Tom Nehl Truck Company, and further authorized to execute a purchase order on behalf of the County for the purchase of one (1) 2016 Roll-Off Truck Bed in the amount of \$151,261.00.

Section 3. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

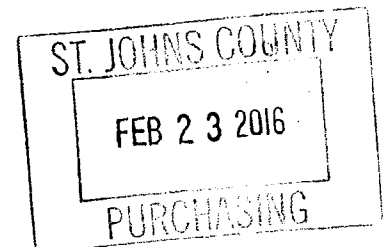



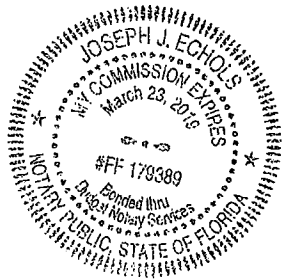
