RESOLUTION  $\mathbf{BY}$ THE **BOARD** OF COUNTY ST. COUNTY, FLORIDA. **JOHNS** COMMISSIONERS  $\mathbf{OF}$ OF RELEASE THE **TERMS** THE APPROVING CONSTRUCTION BOARD OF ADJUSTMENT AND APPEALS LIEN: AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE. TO EXECUTE THE RELEASE OF LIEN ON BEHALF OF ST. JOHNS COUNTY (COUNTY); AND INSTRUCTING THE CLERK OF THE CIRCUIT COURT TO FILE THE RELEASE OF LIEN IN THE PUBLIC RECORDS OF ST. JOHNS COUNTY.

## RECITALS

WHEREAS, on September 22, 2014, pursuant to St. Johns County Ordinance No. 2000-48, Standard Unsafe Building Abatement Code, the St. Johns County Construction Board of Adjustment and Appeals entered a Lien Order in Case No. 13-20, regarding unsafe building violations on a parcel of property owned by respondent Elmer T. Johnson ("Johnson") and located at 477 Old Spanish Trail, St. Johns County, Florida, 32084, Parcel Identification Number 098120-0000; and

WHEREAS, the Lien Order was subsequently recorded in Official Records Book 3935, Page 418, of the public records of St. Johns County, Florida; and

WHEREAS, the Lien Order confirmed the costs incurred by the County for the abatement of an unsafe building violation, plus an administrative fee, totaling \$55,473.00, and assessed the same as a lien against the real and personal property owned by Johnson to the extent permitted by law; and

WHEREAS, since the entry of the Lien Order, Johnson has died and his estate has proceeded through administration in probate; and

WHEREAS, as part of the settlement of Johnson's estate, two parcels of real property located in the County owned by Johnson, including the 477 Old Spanish Trail property, are being sold;

WHEREAS, the personal representative and sole beneficiary of Johnson's estate has proposed to provide to the County the full proceeds of the sale of the two parcels, after fees and taxes, totaling \$41,081.53, as full satisfaction of the County's lien in exchange for a Release of Lien on the 477 Old Spanish Trail property, attached hereto as Exhibit "A" and incorporated herein; and

WHEREAS, the County has reviewed release of the lien and has determined that recovery of the full proceeds of the sale of Johnson's remaining real property located in the County in exchange for release of the lien represents a fair, efficient,

and appropriate resolution of the matter and serves the interests of the County and the public.

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AS FOLLOWS:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as findings of fact.

<u>Section 2</u>. The Board of County Commissioners of St. Johns County, Florida hereby approves the terms, provisions, and conditions of the Release of Lien, and authorizes the County Administrator, or designee, to execute the Release of Lien on behalf of the County, in substantially the same form and format as attached.

<u>Section 3</u>. To the extent that there are typographical and/or administrative errors and/or omissions that do not change the tone, tenor, or content of this Resolution, then this Resolution may be revised without subsequent approval of the Board of County Commissioners.

Section 4. The Clerk of Courts of St. Johns County is instructed to file the Release of Lien in the public records of St. Johns County.
