

**A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO PURCHASE AND EXECUTED A PURCHASE ORDER FOR A FURNITURE PACKAGE BASED ON THE PIGGYBACKED PROCUREMENT FOR THE PURCHASE**

**RECITALS**

**WHEREAS**, the County desires to purchase a furniture package for the Permit Center: and

**WHEREAS**, in accordance with section 302.6.5.4 of the St. Johns county Purchasing Manual, entitled :piggyback or Cooperative Purchasing:, the County is authorized make said purchase subject to the terms and conditions of Florida State Contract #425-01-12-1 (Contract); and

**WHEREAS**, the County was entered into by the State of Florida via a sealed bid process that meets the County's procurement requirements: and

**WHEREAS**, the County wishes to procure furniture from Office Environments & Services, which were awarded the Contract pursuant to the State of Florida's procurement process; and

**WHEREAS**, the furniture package will be purchased through Office Environments & Services, a State-approved servicing dealer for purchase made under the Contract; and

**WHEREAS**, the County has reviewed the terms, provisions, conditions and requirements of the Contract (attached hereto and incorporated herein) and finds that entering into the Contract for purchase of the furniture serves a public purpose.

**NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA**, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.

Section 2. The County Administrator, or designee, is hereby authorized to purchase a furniture package for the Permit Center.

Section 3. In accordance with the terms and conditions of the Contract, the County Administrator, or his designee, is further authorized to execute a purchase order in the amount of \$153,863.59 for purchase of the furniture package from Office Environments & Services.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

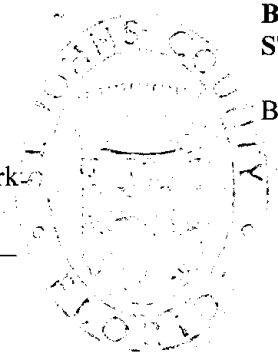
