WHEREAS, the County seeks to purchase two (2) 6" Mobile Diesel Pumps and five (5) 4" Mobile Diesel Pumps; and

WHEREAS, in accordance with section 302.6.5.4 of the St. Johns County Purchasing Manual, entitled "Piggyback or Cooperative Purchasing", the County is authorized make said purchase subject to the terms and conditions of Florida Sheriff's Association contract #FSA17-VEH15.0 ("Contract"); and

WHEREAS, purchase of the equipment will be funded by the Utility Department; and

WHEREAS, the County has reviewed the terms, provisions, conditions and requirements of the Contract and finds that entering into the Contract for purchase of the pumps serves a public purpose.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.

Section 2. The County Administrator, or designee, is hereby authorized to purchase two (2) new 6" Mobile Diesel Pumps and five (5) new 4" Mobile Diesel Pumps.

Section 3. In accordance with the terms and conditions of the Contract, the County Administrator, or designee, is further authorized to execute a purchase order in the amount of \$86,201.18 for the purchase of two 6" Mobile Diesel Pumps and in the amount of \$133,317.80 for the purchase of five (5) 4" Mobile Diesel Pumps for a total of \$219,518.98 from Xylem Dewatering Solutions.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
