A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE CHAIR OF THE BOARD, ON BEHALF OF THE COUNTY, TO EXECUTE AND DELIVER A TEMPORARY EASEMENT TO THE STATE OF FLORIDA DEPARTMENT OF TRANSPORTATION CONVEYING EASEMENT RIGHTS OVER A PORTION OF OCEAN BOULEVARD.

RECITALS

WHEREAS, the State of Florida Department of Transportation ("FDOT") proposes to construct or improve State Road No. 5, Section No. 78020, F.P. No. 4360231 in St. Johns County, Florida; and

WHEREAS, it is necessary that certain lands now owned by St. Johns County ("County"), be temporarily used by FDOT for the project; and

WHEREAS, per the requirements of Section 125.38, Florida Statutes, FDOT has made application to the County to execute and deliver a Temporary Easement, attached hereto as Exhibit "A", incorporated by reference and made a part hereof, in favor of FDOT, for the purpose of modifying existing stop bar and tying and harmonizing said property and the driveways, walkways thereon with the construction to be undertaken by FDOT, in State Road No. 5. Said project is for transportation purposes which are in the public or community interest and for public welfare and said request having been duly considered.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as findings of fact.

Section 2. The Board of County Commissioners hereby authorizes the Chair of the Board, on behalf of the County, to execute and deliver to FDOT the Temporary Easement, attached hereto.

Section 3. The Clerk is instructed to record the original Temporary Easement in the public records of St. Johns County, Florida, and return the original recorded Temporary Easement along with a certified copy of this Resolution to the State of Florida Department of Transportation, 1109 South Marion Ave, MS 2020, Lake City, Florida 32025-5874, Attention: Kiersten Dicks.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
