A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO APPROVE PBM CONSTRUCTORS, INC. TASK ORDER NO. 08 FOR SR 207 MASTER PUMP STATION IMPROVEMENTS UNDER RFP NO. 18-22 (MASTER CONTRACT NO. 18-MCC-PBM-08948)

RECITALS

WHEREAS, On January 22, 2018, the County entered into a task order based continuing services contract with PBM Constructors, Inc.; and;

WHEREAS, the contract requires approval from the St. Johns County Board of County Commissioners on all task orders greater than \$200,000; and;

WHEREAS, the Utility Dept. has a need to issue a task order to PBM Constructors, Inc. for pump station improvements at SR 207 Master Pump Station which will total \$257,998.95; and;

WHEREAS, the task order will be funded through the Utility Department; and;

WHEREAS, the County has reviewed the terms, provisions, conditions and requirements of the proposed task order (attached hereto, an incorporated herein) and finds that executing the task order to complete the work services serves a public purpose; and;

WHEREAS, the task order will be in substantial conformance with the attached draft task order.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.

Section 2. The County Administrator, or designee, is hereby authorized to issue a task order to PBM Constructors, Inc. to provide the services set forth therein.

Section 3. The County Administrator, or designee, is further authorized to execute a task order in substantially the same form and format as the attached draft on behalf of the County to provide the scope of services as specifically provided in the task order.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

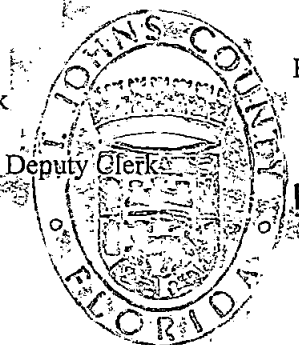

SCOPE OF WORK:

Task Order #8 is hereby issued to authorize PBM Constructors, Inc ("Contractor") to provide installation, testing, and startup of two Owner-furnished non-clog dry pit centrifugal pumps and all ancillary equipment, including, but not limited to the motor, and the associated wiring to supply power, plus providing all labor, materials and equipment to provide a complete and fully functional system per the technical specifications and drawings provided by CH2M Hill dated September 2018 and in the Contractor's proposal dated October 1, 2018, attached hereto. The authorized work shall generally include the following task:

- Demolition work
- New Pump pad
- Install dry pits pumps furnished by the SJCU
- Install new pipe, valves and fittings as per plans
- Install insertion flowmeter
- New backflow preventer
- New concrete apron
- Electrical demo and new wiring for pumps and controls
- Work with instrumentation contractor to install all field instruments

PAYMENT TERMS:

The County shall compensate the Contractor, under Task Order #8, a not-to-exceed amount of two hundred fifty seven thousand nine hundred ninety eight dollars and ninety five cents (\$257,998.95) for work satisfactorily completed in accordance with the provisions of this task order, and with the Master Contract dated January 22, 2018.

SCHEDULE:

The County shall issue a Notice to Proceed to the Contractor upon receipt of a recorded Public Construction Bond. **Work shall commence upon receipt of the Notice to Proceed and shall be completed within ninety (90) consecutive calendar days from the Notice to Proceed date.** The Effective Date of this Task order shall be the date of signature by an authorized St. Johns County Representative. The All terms and conditions of the above-referenced contract remain in full force and effect. Any work performed prior to full execution of this Task Order shall be at the Contractor's Own Risk.

Receipt of a fully executed copy of this Task Order shall serve as the Notice to Proceed for this project.
