- 1. It is hereby found and determined that the action taken in paragraph # 2 below is in the best interest of the public.
- 2. That the following described right-of-way or portions thereof to wit:

be and the same are hereby vacated, abandoned, discontinued and closed, and this Board hereby renounces and disclaims any right of the County and the Public in and to the above described right-of-way and any land in connection therewith.

- 3. As a condition to such vacation, to the extent allowed by law there is hereby reserved unto JEA a perpetual non-exclusive easement on, over, across, under and through the closed portions of such right-of-way for electric, water, sewer, and reuse water utilities.
- 4. That the notice required by Section 336.10, Florida Statutes, of the adoption of this resolution is hereby authorized to be published and recorded.
- 5. That the applicant pays all recording costs.


Debbies Way Closure

A portion of Section 55, of the Pedro Miranda Grant, Township 4 South, Range 29 East, St. Johns County, Florida, also being a portion of those lands described and recorded in Official Records Book 4012, page 1931, of the Public Records of said county, being more particularly described as follows:

For a Point of Reference, commence at the Southeasterly most corner of Twenty Mile at Nocatee Phase 4A, a plat recorded in Map Book 78, pages 57 through 76 of said Public Records, said corner lying on the Northerly right of way line of Debbies Way, a 100 foot right of way as presently established; thence North 79°08'31" East, along said Northerly right of way line, 27.07 feet to the Point of Beginning.
