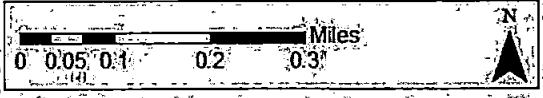
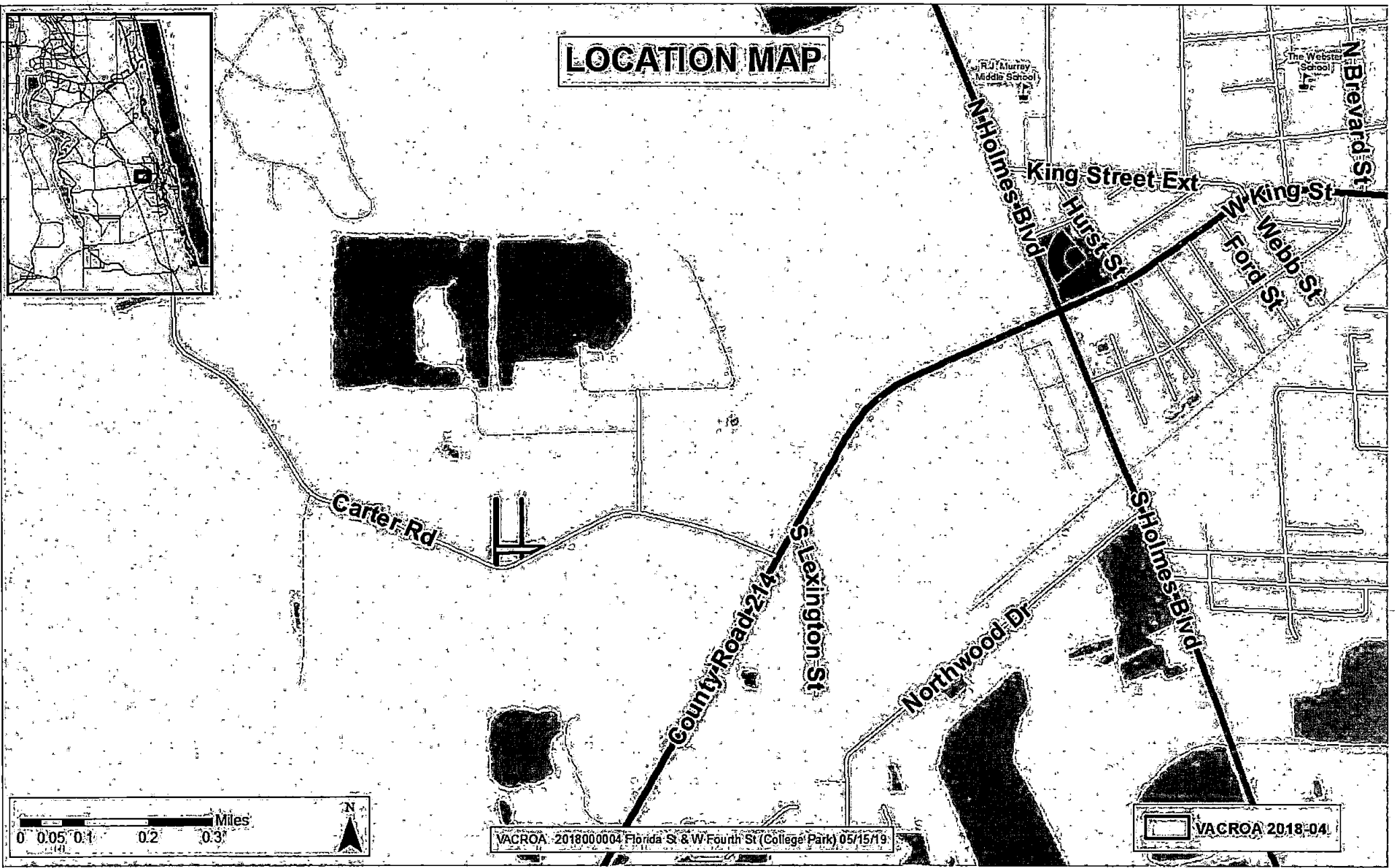
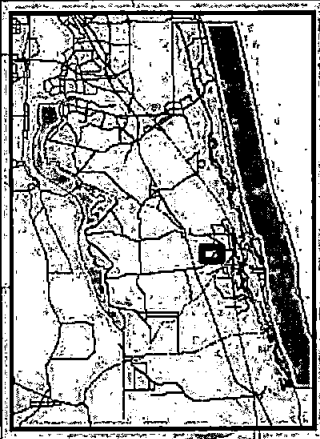


SCHEDULE "A"

LEGAL DESCRIPTION OF VACATED ROAD AND ALLEYWAY

THE UNIMPROVED PORTION OF WEST FOURTH STREET (A 55 FOOT WIDE RIGHT-OF-WAY) THAT RUNS EASTERLY AND WESTERLY BETWEEN BLOCKS 17 AND 18, AS DEPICTED ON THE PLAT OF COLLEGE PARK, AS RECORDED IN MAP BOOK 2, PAGE 55 OF THE PUBLIC RECORDS OF ST. JOHNS COUNTY, FLORIDA, LYING NORTH OF THE NORTH RIGHT-OF-WAY LINE OF CARTER ROAD, AS IT CURRENTLY EXISTS, THE UNIMPROVED 20' ALLEYWAY BETWEEN LOTS 1 THROUGH 12 OF BLOCK 17 AND LOTS 1 AND 2 OF BLOCK 18 OF SAID COLLEGE PARK, LYING NORTH OF THE NORTH RIGHT-OF-WAY LINE OF CARTER ROAD, AND THE UNIMPROVED PORTION OF FLORIDA STREET (A 55 FOOT WIDE RIGHT-OF-WAY), THAT RUNS NORTH AND SOUTH, ADJACENT TO BLOCK 17 AND 18 OF SAID COLLEGE PARK NORTH OF CARTER ROAD, AS IT CURRENTLY EXISTS.

LOCATION MAP



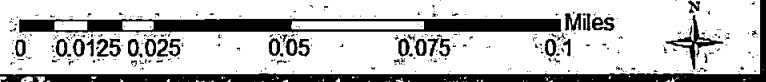
