### RESOLUTION NO. 2019 - 202

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2019 UTILITY FUND BUDGET IN ORDER TO RECEIVE UNANTICIPATED REVENUE FOR THE NORTHEAST GROUND STORAGE TANK AND HIGH SERVICE PUMPING STATION PROJECT BY THE ST. JOHNS COUNTY UTILITY DEPARTMENT.

WHEREAS, St. Johns County maintains a Capital Improvement Program (CIP) under the Utility System Enterprise Fund; and

WHEREAS, the Utility Department has been awarded an allocation of \$3,326,290 for fiscal year 2019 by the Florida Department of Environmental Protection (FDEP) at the Drinking Water State Revolving Fund (SRF) Priority List meeting on May 8<sup>th</sup>, 2019; and

WHEREAS, the awarded allocation of \$3,326,290 will be added to the fiscal year 2019 Utility System Enterprise Fund CIP budget; and

WHEREAS, these revenues were not awarded during the preparation of the 2019 fiscal year budget, and the recognition of these funds as current year revenues is required to enable their appropriation towards the award of the Northeast Ground Storage Tank and High Service Pumping Station project, bid No. 19-55, which was completed on May 8<sup>th</sup>, 2019. Through the County's formal Bid process, <u>Sawcross</u>, <u>Inc.</u> was the lowest, responsive, responsible bidder to perform the work for an amount of \$2,893,000.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:

- 1. The above Recitals are incorporated by reference into the body of this Resolution, and such Recitals are adopted as Findings of Fact.
- 2. The Fiscal Year 2019 Utility Fund revenue and expenditure budgets shall be adjusted to account for unanticipated revenue in the amount of \$3,326,290 from the Department of Environmental Protection State Revolving Loan Program as awarded at the first fiscal year 2019 priority list meeting.
- 3. To the extent that there are scriveners, typographical or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
