RESOLUTION BY OF THE BOARD COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING THE TERMS, CONDITIONS, REQUIRMENTS OF A U.S. DEPARTMENT OF HOMELAND SECURITY STAFFING FOR ADEQUATE FIRE RESPONSE EMERGENCY (SAFER) **GRANT** AUTHORIZING THE COUNTY ADMINISTRATOR OR HIS DESIGNEE, TO ACCEPT THE GRANT AWARD ON BEHALF OF ST. JOHNS COUNTY.

WHEREAS, at its December 18, 2018 meeting the St. Johns County Board of County Commissioners authorized the submittal of an application for a 2018 Staffing for adequate Fire and Emergency Response (SAFER) grant on behalf of the County for the purpose of funding additional firefighter positions for St. Johns County Fire Rescue; and

WHEREAS, the U.S. Department of Homeland Security has announced that St. Johns County is eligible to receive a SAFER Grant with a total federal contribution of \$2,373,490.80; and

WHEREAS, the SAFER Grant will allow St. Johns County Fire Rescue to hire an additional 18 firefighters; and:

WHEREAS, the SAFER Grant contains a required match of \$1,475,413.20 over the 3-year performance period of the grant for a total project cost of \$3,848,904.00; and

WHEREAS, acceptance of the SAFER Grant award will serve the interests of the County.

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISIONERS OF ST. JOHNS COUNTY:

- **Section 1.** The above recitals are hereby incorporated into the body of this resolution and are adopted as findings of fact.
- Section 2. The Board of County Commissioners approves the terms, conditions, and requirements of the SAFER award and authorizes the County Administrator, or his designee, to accept the award on behalf of St. Johns County.
- **Section 3.** If there are typographical or administrative errors or omissions that do not change the tone, tenor or context of this resolution, this resolution may be revised without subsequent approval of the Board of County Commissioners.
- Section 4. This resolution shall be effective upon adoption by the board of County Commissioners.


