

RESOLUTION 2019 - 418

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING THE RE-APPROPRIATION OF FUNDS RECEIVED IN THE FY19 PARK IMPROVEMENT ASSOCIATION FEE BUDGET LINE AND CARRIED FORWARD INTO FY20.**

**WHEREAS**, the Parks and Recreation Department has established a process by which athletic organizations or individuals may propose modifications or improvements to County-owned recreation facilities; and

**WHEREAS**, the process involves submitting a Facility Modification form that includes a detailed description of the project, quotes for completion of the work and a donation of funding to complete the work; and

**WHEREAS**, in the latter part of FY 2019, the Parks and Recreation Department received Facility Modification Requests with fund donations to purchase new netting for batting cages at Davis Park Baseball Complex with funds donated by PVAA Baseball partnered with SJMSAA, and to install irrigation improvements and a replacement shed at Palencia Park athletics fields with funds donated by Villages Baseball Association; and

**WHEREAS**, as part of the County's budget process, the total amount of the donations (\$15,499.20) was carried forward from the FY19 County's Park Improvement Association Fee budget line to the FY20 General Fund; and

**WHEREAS**, a re-appropriation of the donated funds to the respective FY20 Park Improvement Association Fee budget lines is necessary to complete the proposed modifications/improvements described herein.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:

**Section 1.** The above Recitals are incorporated by reference into the body of this Resolution, and such Recitals are adopted as Findings of Fact.


**Section 2.** The Board of County Commissioners hereby approves and authorizes the County Administrator, or designee, to submit a completed application (attached hereto, and incorporated herein), on behalf of the St. Johns County Solid Waste Management Department for a Florida Department of Environmental Protection Grant for funding extension of the County's household hazardous waste program to certain areas of the County.

**Section 3.** The Board hereby authorizes the transfer of \$15,499.20 from the General Fund, and the appropriation of \$5,920.20 to line 0080-55200 to purchase batting cage netting at Davis Park Baseball Complex; the appropriation of \$4,350.00 to line 0080-54626 for irrigation improvements at Palencia Park athletic field irrigation improvements; and the appropriation of \$5,229 to line 0080-56400 to install a replacement baseball shed at Palencia Park.

**Section 4.** To the extent that there are typographical and/or administrative errors that do not change the tone, tenor or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
