#### RESOLUTION NO. 2020- 136

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING THE ROAD RENAMING OF POPLAR AVENUE IN SURFSIDE SUBDIVISION TO VIVIAN BROWNING AVENUE.

#### RECITALS

WHEREAS, Section 6.02.03 B. of the St. Johns County Land Development Code ("LDC") and Section 336.05, Florida Statutes, provides that the Board of County Commissioners has the authority to rename roads, except state roads designated by number by the Florida Department of Transportation, lying outside any incorporated municipality; and

WHEREAS, Vivian Browning has been an involved Vilano Beach community member for over two decades and has held leadership roles in various community-interest groups such as the North Shores Improvement Association, Main Street Vilano and the St. Johns County Mosquito Control District Board; and

WHEREAS, Ms. Browning played an integral part in code development for Vilano Main Street and in bringing in community services to Vilano, such as Publix and a volunteer postal station to serve Vilano Beach residents and has worked diligently with others for Vilano Beach to be named a Trail Town and become part of the Greenway; and

WHEREAS, the Board of Vilano Beach Main Street, on behalf of the Town Center and area residents, submitted a petition pursuant to Section 6.02.03 of the LDC to rename Poplar Avenue to Vivian Browning Avenue in honor of her dedication and contributions made to the Vilano Beach community. The Petition was signed by more than 51% of the adjoining property owners. There was no opposition to the "notice of intent to change the roadway name" that was noticed pursuant to the requirements of the LDC; and

WHEREAS, the Board of County Commissioners has found it to be in in the public interest to rename this road as requested in the petition.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as findings of fact.

Section 2. Poplar Avenue is hereby renamed to Vivian Browning Avenue.

Section 3. The Clerk shall record this Resolution in the public records of St. Johns County, Florida.

This petition is being processed in accordance with the St. Johns County Land Development Code Article VI Section 6.02.03. You have fifteen (15) days to send your response to this notice if you are opposed to the name. If there is no response in opposition received, the County Administrator will consider the roadway name change petition and approve or deny the request.

If there is opposition received to the roadway name change petition and alternate names are considered, the County Administrator may schedule a public hearing with the Board of County Commissioners. Notice will be mailed at least ten (10) days before the hearing. Those in favor or against the petition will have an opportunity to present their position on the matter before the Board of County Commissioners. The board will approve or deny the request for the roadway name change.

The County will notify the property owners owning or abutting the roadway affected stating the outcome of the hearing as to whether the road naming petition was approved or denied. If approved, the County will notify the property owners affected with their change of address.


