RECITALS

- Section 2. The County Administrator, or designee, is hereby authorized to assign the lease agreement with Seating Solutions, Inc., under Bid No. 18-74 to InProduction, Inc.
- Section 3. The County Administrator, or designee, is further authorized to execute an assignment agreement in substantially the same form and format as attached hereto with InProduction, Inc. on behalf of the County for the lease agreement under Bid No. 18-74.
- Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

CONSENT TO ASSIGNMENT

This Consent to Assignment Agreement (Agreement) is entered into	as of this day of

State of Florida, ("Assignee"). Capitalized terms used but not defined he	rein shall have the meanings
ascribed to them in that certain Lease Agreement 18-LEA-RIO-09759, dated	as of September 20, 2018.

WHEREAS, RI, Inc dba Seating Solutions ("Lessor") and County wish to transfer and assign to the Assignee all of the Lessor's rights and interests in and to, and obligations under Lease Agreement 18-LEA-RIO-09759, and the Assignee wishes to be the assignee and transferee of such rights, interests and obligations; and

WHEREAS, pursuant to the Lease Agreement 18-LEA-RIO-09759, the Lessor or County may not assign any of its rights, interests or obligations under the such agreement, directly or indirectly (by operation of law or otherwise), without the prior written approval of the Other; and

WHEREAS, on July 30, 2019, Lessor provided its written request to assign of all of its rights, interests and obligations in Lease Agreement 18-LEA-RIO-09759 to the Assignee based on the Assignee's acquisition of the Lessor (see Exhibit A, attached hereto and incorporated herein); and

WHEREAS, as a result of the acquisition, the Lease Agreement must be assigned to the Assignee to continue.

NOW, THEREFORE, the parties hereto, intending to be legally bound, do hereby agree as follows:

- 1. Assignment and Assumption. The County hereby consents to the assignment of Lease Agreement 18-LEA-RIO-09759 to Assignee, who shall acquire all of the Lessor's rights, interests, obligations and duties as set forth in such agreement. By execution of this Agreement, Assignee hereby assumes and agrees to perform all obligations, duties, liabilities and commitments of the Consultant as provided in Lease Agreement 18-LEA-RIO-09759.
- 2. Incorporation of Terms and Conditions. Lease Agreement 18 LEA-RIO-09759 is hereby incorporated into and made part of this Agreement. With the exception to the assignment of rights, interests, obligations and duties as set forth herein, all terms, conditions and provision contained in Lease Agreement 18-LEA-RIO-09759 shall remain in full force and effect.
- 3. Effectiveness, This Assignment Agreement shall be effective as of the date first set forth above.
- 4. Governing Law and Venue. This Agreement shall be governed by and construed in accordance with the laws of the State of Florida. Venue for any administrative this Agreement shall be in St. Johns County, Florida.
- 5. Counterparts. This Agreement may be executed in one or more counterparts, including facsimile counterparts, each of which shall be deemed to be an original copy of this Assignment Agreement, and all of which, when taken together, shall be deemed to constitute one and the same agreement. Delivery of such counterparts by facsimile or electronic mail (in PDF or .tiff format) shall be deemed effective as manual delivery.
