RESOLUTION 2020 - 100

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2020 BUDGET TO RECEIVE UNANTICIPATED REVENUE; AND AUTHORIZING ITS APPROPRIATION AND EXPENDITURE BY THE ST. JOHNS COUNTY PARKS AND RECREATION DEPARTMENT

WHEREAS, the Parks and Recreation Department has established a process by which athletic organizations or individuals may propose modifications or improvements to County-owned recreation facilities; and

WHEREAS, the process involves submitting a Facility Modification form that includes a detailed description of the project, quotes for completion of the work and a donation of funding to complete the work; and

WHEREAS, as Ponte Vedra Baseball has donated \$13,200.00 to the County's Park Improvement Association Fee budget line to the FY20 General Fund; and

WHEREAS, a re-appropriation of the donated funds from the respective FY20 Park Improvement Association Fee budget line is necessary to complete the proposed modifications/improvements described herein.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

- 1. The above recitals are incorporated by reference into the body of this Resolution, and such recitals are adopted as findings of fact.
- 2. The Board hereby authorizes the transfer of \$13,200.00 from 0001-34792, Park Improvement Association Fee and the appropriation of these funds to line 0080-55200, Operating Supplies for the purchase and installation of 400' of chainlink fence for the outfield at Davis Park Baseball Fields.
- 3. To the extent that there are typographical or administrative errors that do not change the tone, tenor or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board.



Newsom Fence will cut in a 12' wide double swing gate in the existing fence along the foul line as requested. The gate will have a lockable center drop bar. The material on the double swing gate will match the surrounding fence material along the foul line.

All the outfield fencing will be green. A top rail and bottom tension wire will be installed along the entire fence. The corner posts will be braced. All the posts will be set in concrete. All material will be full weight commercial grade.

- Chain Link Wire: 6 gauge vinyl coated finish w/ a 9 gauge galvanized core wire
- Top Rail: 1 5/8" diameter s40 weight
- Line Post: 2 ½" diameter s40 weight
- Corner Post: 3" diameter s40 weight

- Bottom Tension Wire: 6 gauge spring coiled
- Tie Wires: vinyl coated 9 gauge galvanized steel
