COUNTY RESOLUTION \mathbf{BY} THE BOARD OF COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA. ACCEPTING THE MODIFICATIONS TO THE FLORIDA DISTRICT **NAVIGATION** WATERWAYS INLAND ASSISTANCE PROGRAM GRANT FOR THE **VILANO** LANDING DREDGE PROJECT.

WHEREAS, on March 17, the Board of County Commissioners approved staff to apply for a 75/25 match Dredge Grant through the Florida Inland Navigational District (FIND); and

WHEREAS, the project is estimated to cost \$240,000 with \$60,000 funding from the County's surplus funds. The remaining \$180,000 would be reimbursed through FIND; and

WHEREAS, after the grant was submitted, staff was informed that the project was only eligible for a 50/50 match as the dredge was associated with a boat ramp; and

WHEREAS, the grant has been submitted and will be considered for funding, however the application will need to be revised before May 22 to comply with a 50/50 match; and

WHEREAS, the County has determined that the modification of the award by the Florida Inland Navigation District Waterways Assistance Program Grant for funding for the dredging project at Vilano Landing serves the overall interests of the County; and

WHEREAS, staff will pursue other options and opportunities to assist with funding the additional 25% of the Vilano Landing Dredge project.

NOW, THEREFORE BE IT RESOLVED, by the Board of County Commissioners of St. Johns County, Florida that:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution, and such Recitals are adopted as Findings of Fact.

Section 2. The Board of County Commissioners hereby approves and authorizes the County Administrator, or designee, to approve the Florida Inland Navigation District Waterways Assistance Program Grant Resolution (attached hereto, and incorporated herein), on behalf of the St. Johns County Parks and Recreation Department for a Florida Inland Navigation District Waterways Assistance Program Grant for funding of the dredging project at Vilano Landing.

Section 3. The Board of County Commissioners hereby authorizes the County Administrator, or designee, to execute any other paperwork necessary, and/or associated with the application for a Florida Inland Navigation District Waterways Assistance Program Grant for the dredging of Vilano Landing.
