A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO AWARD RFP NO: 20-75 AND TO EXECUTE AN AGREEMENT FOR IN-HOUSE TURN-KEY PARTS OPERATION.

RECITALS

WHEREAS, the County desires to enter into negotiations with Genuine Parts Company to provide an in-house turn-key parts operation during the working hours of the St. Johns County Fleet Maintenance Department and upon successful negotiations, enter into a contract; in accordance with RFP No. 20-75; and

WHEREAS, the scope of the services will be to provide the necessary personnel, management, parts, and supplies to run an efficient and effective in-house turn-key parts operation that covers working hours worked in the St. Johns County Fleet Maintenance Department. This will include the availability of parts during normal operating hours, as well as peak demand hours. These normal hours are subject to change during the term of the Contract. It may also be necessary that the facility operate under emergency conditions and be open weekends, holidays, or on a 24 hour basis, as determined by the County, in accordance with RFP No. 20-75; and

WHEREAS, through the County's formal RFP process, Genuine Parts Company was the top ranked firm; and

WHEREAS, the County has reviewed the terms, provisions, conditions and requirements of the proposed contract (attached hereto, an incorporated herein) and finds that entering into contract to complete the work services serves a public purpose.

WHEREAS, the contract will be finalized after negotiations but will be in substantial conformance with the attached draft contract.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

- Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.
- Section 2. The County Administrator, or designee, is hereby authorized to conduct negotiations with Genuine Parts Company to provide the services set forth therein.
- Section 3. Upon successful negotiations, the County Administrator, or designee, is further authorized to execute agreements in substantially the same form and format as the attached draft on behalf of the County to provide the scope of services as specifically provided in RFP 20-75.
- Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
