JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO AWARD BID NO: 20-23; PURCHASE OF MECHANICAL BANDSCREEN AND SCREENINGS WASH PRESS FOR ANASTASIA ISLAND WASTEWATER TREATMENT PLANT TO HYDRO-DYNE ENGINEERING AND TO EXECUTE AN AGREEMENT FOR COMPLETION OF THE WORK.

RECITALS

WHEREAS, the County desires to enter into a contract with Hydro-Dyne Engineering, for the Purchase of Mechanical Bandscreen and Screenings Wash Press for Anastasia Island Wastewater Treatment Plant; and

WHEREAS, the purpose of this bid is to solicit responses from qualified and interested firms to provide the St. Johns County Utility Department with two (2) screening removal and washing systems including all labor, materials, equipment, and required incidentals. This work includes testing of a system that is complete and ready for operation. This system includes two center-flow bandscreens with integrated screenings washer-compactor, chutes, control panel, and appurtenant equipment as shown on the Drawings and as specified. The equipment will be delivered to Anastasia Island Wastewater Treatment Plant located at 860 W 16th St., St. Augustine, FL 32080.

WHEREAS, through the County's formal Bid process Hydro-Dyne Engineering, was determined to be the lowest, responsive, responsible bidder and;

WHEREAS, the County has reviewed the terms, provisions, conditions and requirements of the purchase and finds the purchase of the specified equipment services serves a public purpose.

WHEREAS, the project will be funded by the SJC Utility Department.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

- Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.
- Section 2. The County Administrator, or designee, is hereby authorized to award Bid 20-23; Purchase of Mechanical Bandscreen and Screenings Wash Press for Anastasia Island Wastewater Treatment Plant to Hydro-Dyne Engineering, for the purchase of equipment as specified within the bid documents for the Utility Department.
- Section 3. Upon Board approval, the County Administrator, or designee, is authorized to execute a purchase order in the amount of \$540,000.00 for the purchase of the specified equipment as specifically provided in Bid 20-23.
- Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
