

RESOLUTION NO. 2020 - 92

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO PURCHASE AND EXECUTE A PURCHASE ORDER FOR WATER METER EQUIPMENT.

RECITALS

WHEREAS, the County seeks to purchase water meter equipment for St Johns County Utility Department; and

WHEREAS, in accordance with section 302.5 of the St. Johns County Purchasing Manual, entitled "Standardization", the County is authorized to make said purchase in order to standardize and upgrade the current water meters; and

WHEREAS, Resolution 88-11 authorized standardization of the purchasing the meters from Rockwell International, Rockwell Water Meter Division, AKA Sensus USA, Inc., which authorizes purchase without public solicitation, and

WHEREAS, HD Supply Waterworks is the Sole Distributor for Sensus water meters, and

WHEREAS, HD Supply Waterworks name has changed to Core & Main, the local distributor, and

WHEREAS, St Johns County Utility Department is able to purchase the meters directly from Sensus, USA, Inc., the manufacturer for a total savings of \$18,483.07, and

WHEREAS, the purchase of the water meter equipment will be funded by St Johns County Utility Department; and

WHEREAS, the purchase of the water meter equipment serves a public purpose.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.

Section 2. The County Administrator, or designee, is hereby authorized to purchase the water meter equipment.

Section 3. Upon Board approval, the County Administrator, or designee, is authorized to execute a purchase order in the amount of \$383,767.93 for the purchase of the water meter equipment from Sensus, USA, Inc.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

WHEREAS, the Anastasia Sanitary District and Mainland Water System under the governing body of the St. Johns County Board of County Commissioners have installed a specific type of water meter over the years, and

WHEREAS, the specific water meters utilized and installed by Anastasia Sanitary District and Mainland are manufactured by Rockwell International, and

WHEREAS, Anastasia Sanitary District and Mainland Water System meters are read by an Automated Meter Reading System provided only by Rockwell International, giving meter readings by touch, and

WHEREAS, future purchases of water meters must all be purchased from Rockwell International the only source of meter compatible with the Automatic Meter Reading System,

NOW THEREFORE BE IT RESOLVED, by the Board of County Commissioners, as governing body of Anastasia Sanitary District and Mainland Water System authorizes the Director of Utilities of Anastasia Sanitary District and the County Administrator to purchase as sole source, the water meters from Rockwell International as required, as provided in Florida Law 81-843 paragraph (d) when goods, supplies, or materials are available from only one source.
