RESOLUTION NO. 2021 - 266

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, RECOGNIZING AND APPROPRIATING A US DEPARTMENT OF HOMELAND SECURITY FEMA GRANT AND A STATE OF FLORIDA DIVISION OF EMERGENCY MANAGEMENT GRANT WITHIN THE FISCAL YEAR 2021 GENERAL FUND BUDGET.

RECITALS:

WHEREAS, Hurricanes Matthew and Irma inflicted severe impacts to Florida resulting in a presidential declaration for federal assistance in St. Johns County; and

WHEREAS, the County sustained damages from Hurricanes Matthew and Irma and is responsible for repairs to public property; and

WHEREAS, the County estimates the eligible costs for repairs to be \$34,366,566.60 related to Hurricanes Matthew and Irma; and

WHEREAS, it is estimated that the County will receive up to \$27,056,875.63 from a Department of Homeland Security FEMA grant related to Hurricanes Matthew and Irma which necessitates a County match; and

WHEREAS, it is estimated that the County will receive up to \$2,933,845.48 from a State of Florida Division of Emergency Management grant; and

WHEREAS, the County did not anticipate either an award of a Department of Homeland Security FEMA grant or a State of Florida Division of Emergency Management grant related to Hurricanes Matthew and Irma during the Fiscal Year 2021 budget process; and

WHEREAS, the County must recognize and appropriate \$27,056,875.63 from a FEMA grant and \$2,933,845.48 from a State of Florida Division of Emergency Management grant within the collective Fiscal Year 2021 General Fund.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida:

- 1. The above recitals are hereby adopted as legislative findings of fact and incorporated herein.
- 2. The Board of County Commissioners recognizes and appropriates a tentative Department of Homeland Security FEMA grant for up to \$27,056,875.63 and a tentative State of Florida Division of Emergency Management grant for up to \$2,933,845.48 related to Hurricanes Matthew and Irma within the Fiscal Year 2021 General Fund Budget.
- 3. To the extent there are typographical errors that do not substantively change the tone, tenor, or concept of this resolution, this resolution may be revised without subsequent approval by the Board of County Commissioners.
