

**RESOLUTION NO. 2021- 339**  
**RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS**  
**OF ST. JOHNS COUNTY, FLORIDA APPROVING A PLAT FOR**  
**SILVERLEAF 29B-1**

**WHEREAS, RICHMOND AMERICAN HOMES OF FLORIDA, LP, A COLORADO LIMITED PARTNERSHIP, AS OWNER,** has applied to the Board of County Commissioners of St. Johns County, Florida for approval to record a plat known as Silverleaf 29B-1

**NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA,** as follows:

**Section 1.** The above-described subdivision plat and its dedicated areas depicted thereon are conditionally approved and accepted by the Board of County Commissioners of St. Johns County, Florida subject to Sections 2, 3, 4, 5 and 6.

**Section 2.** A Required Improvements Bond in the amount of \$4,938,535.04 has been filed with the Clerk's office.

**Section 3.** A Required Improvements Bond in the amount of \$890,791.00 is required for maintenance.

**Section 4.** The approval and acceptance described in Section 1 shall not take effect until the Clerk has received a title opinion, certificate, or policy pertaining to the real property that is the subject of the aforementioned subdivision plat which opinion, certificate or policy is in a form acceptable to the County Attorney or Assistant County Attorney.

**Section 5.** The Clerk is instructed to file and record the consent and joinder(s) to the plat executed by all mortgagees identified in the title opinion or certificate of the title in Section 4.

**Section 6.** The approval and acceptance described in Section 1 shall not take effect until the plat has been signed by each of the following departments, person or offices:


- a) Chairman or Vice-Chairman of the Board of County Commissioners of St. Johns County, Florida;
- b) Office of the County Attorney;
- c) County Growth Management Department;
- d) Office of the County Surveyor; and
- e) Clerk of Courts.

The Clerk shall not sign or accept the Plat for recording until it has been signed by each of the above persons or entities described in a) through d) above. If the plat is not signed and accepted by the Clerk for recording within 14 days from the date hereof, then the above-described conditional approval shall


automatically terminate. If the plat is signed by the Clerk on or before such time, the conditions described herein shall be deemed to have been met.


## CAPTION

A portion of Subsection 5 of Section 38 of the Antonio Huertas Grant, Township 6 South, Range 28 East, St. Johns County, Florida, being more particularly described as follows:

For a Point of Reference, commence at the Northeastly corner of said Subsection 5; thence South 18°40'32" West, along the Easterly line of said Subsection 5, a distance of 75.02 feet to the Point of Beginning.

thence Northwesterly along the arc of a curve concave Southwesterly having a radius of 250.00 feet, through a central angle of 55°35'02", an arc length of 245.89 feet to the point of tangency of said curve, said arc being subtended by a chord bearing and distance of North 48°48'18" West, 236.98 feet; thence North 77°03'49" West, 623.30 feet to the point of curvature of a curve concave Southerly having a radius of 435.00 feet; thence Westerly along the arc of said curve, through a central angle of 06°10'51", an arc length of 46.93 feet to a point of reverse curvature, said arc being subtended by a chord bearing and distance of North 89°09'14" West, 48.90 feet; thence Northwesterly along the arc of a curve concave Northerly having a radius of 50.00 feet, through a central angle of 85°31'01", an arc length of 83.35 feet to a point of reverse curvature, said arc being subtended by a chord bearing and distance of North 35°29'09" West, 74.03 feet; thence Northwesterly along the arc of a curve concave Southwesterly and having a radius of 330.00 feet, through a central angle of 108°58'18", an arc length of 625.52 feet, said arc being subtended by a chord bearing and distance of North 42°01'47" West, 535.99 feet; thence South 24°43'19" East, along a non-tangent line, 84.85 feet to the point of curvature of a curve concave Westerly having a radius of 275.00 feet; thence Southerly along the arc of said curve, through a central angle of 32°05'16", an arc length of 154.01 feet, said arc being subtended by a chord bearing and distance of South 06°40'41" East, 102.01 feet; thence North 82°30'33" West, along a non-tangent line, 50.00 feet to a point on a non-tangent curve concave Westerly having a radius of 225.00 feet; thence Southerly along the arc of said curve, through a central angle of 23°41'42", an arc length of 93.05 feet, said arc being subtended by a chord bearing and distance of South 19°12'48" West, 92.39 feet; thence South 68°10'39" West, along a non-tangent line, 179.35 feet to a point lying on the Easterly right of way line of Silverleaf Parkway, a 150 foot right of way as depicted on St. Johns Parkway and Silverleaf Parkway, recorded in Map Book 97, pages 23 through 43, of the Public Records of said county; thence Northwesterly along said Easterly right of way line the following 5 courses: Course 1, thence South 89°25'11" West, 25.33 feet; Course 2, thence North 89°19'18" West, 58.92 feet; Course 3, thence North 37°39'32" West, 183.60 feet to a point on a non-tangent curve concave Westerly having a radius of 1275.00 feet; Course 4, thence Northerly along the arc of said curve, through a central angle of 16°51'26", an arc length of 375.12 feet to the point of tangency of said curve, said arc being subtended by a chord bearing and distance of North 16°17'36" West, 373.77 feet; Course 5, thence North 24°43'19" West, 288.83 feet; thence North 69°16'41" East, 250.00 feet to the point of curvature of a curve concave Westerly having a radius of 60.00 feet; thence Northerly along the arc of said curve, through a central angle of 90°00'00", an arc length of 94.25 feet to the point of tangency of said curve, said arc being subtended by a chord bearing and distance of North 20°18'41" East, 84.65 feet; thence North 24°43'19" West, 149.10 feet to the point of curvature of a curve concave Southeastly having a radius of 55.00 feet; thence Northerly along the arc of said curve, through a central angle of 107°11'46", an arc length of 102.50 feet to the point of tangency of said curve and to the Southerly right of way line of Courtney Vista Drive, a variable width public right of way as currently established, said arc being subtended by a chord bearing and distance of North 28°52'34" East, 88.54 feet; thence Easterly along said Southerly right of way line the following 11 courses: Course 1, thence North 82°28'27" East, 84.04 feet; Course 2, thence North 84°25'24" East, 286.74 feet to the point of curvature of a curve concave Northerly having a radius of 3040.00 feet; Course 3, thence Easterly along the arc of said curve, through a central angle of 00°27'50", an arc length of 24.62 feet, said arc being subtended by a chord bearing and distance of North 84°12'29" East, 24.62 feet; Course 4, thence South 82°41'30" East, along a non-tangent line, 31.84 feet to a point on a curve concave Northerly having a radius of 3047.50 feet; Course 5, thence Easterly along the arc of said curve, through a central angle of 02°13'49", an arc length of 118.83 feet, said arc being subtended by a chord bearing and distance of North 82°16'42" East, 118.83 feet; Course 6, thence South 54°25'26" East, 35.57 feet; Course 7, thence South 09°46'37" East, 77.50 feet; Course 8, thence North 89°13'23" East, 50.00 feet; Course 9, thence North 09°46'37" West, 85.00 feet; Course 10, thence North 34°52'10" East, 35.57 feet to a point on a non-tangent curve concave Northerly having a radius of 3040.00 feet; Course 11, thence Easterly along the arc of said curve, through a central angle of 06°22'20", an arc length of 338.10 feet, said arc being subtended by a chord bearing and distance of North 76°05'40" East, 337.92 feet; thence South 56°33'34" East, departing said Southerly right of way line, along a non-tangent line, 275.74 feet; thence North 86°42'45" East, 211.13 feet; thence North 67°37'26" East, 718.79 feet to a point lying on the Southwesterly line of that certain Florida Power and Light Easement as described and recorded in Official Records Book 952, page 929, of said Public Records; thence South 72°44'25" East, along said Southwesterly line, 241.74 feet to the Point of Beginning.
