A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF JOHNS COUNTY, FLORIDA, APPROVING THE TERMS, CONDITIONS, PROVISIONS, AND REQUIREMENTS OF A STATE-FUNDED GRANT SUPPLEMENTAL AGREEMENT BETWEEN THE FLORIDA DEPARTMENT OF TRANSPORTATION AND ST. JOHNS \$150,000 RELATING TO COUNTY IN THE AMOUNT OF IMPROVEMENTS TO SR 313 AT US-1; AUTHORIZING THE COUNTY **EXECUTE** THE DESIGNEE, TO ADMINISTRATOR. OR SUPPLEMENTAL AGREEMENT ON BEHALF OF ST. JOHNS COUNTY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, St. Johns County ("County") and the Florida Department of Transportation ("FDOT") have previously entered into a State-Funded Grant Agreement ("Agreement") providing for funding of improvements to State Road 313 at US-1, as reflected in St. Johns County Resolution No. 2019-401; and

WHEREAS, FDOT has informed the County that funds have been approved additional fund for improvements at the referenced location; and

WHEREAS, in order to allow for FDOT to provide additional funds to remove concrete beneath US-1 located within the area of the improvements to the State Road 313 and US-1 intersection, the County and FDOT wish to enter into a State-Funded Grant Supplemental Agreement ("Supplemental Agreement"), attached hereto as Exhibit A and incorporated herein by reference; and

WHEREAS, the State of Florida's Department of Transportation will award the funds to the County pursuant to the State-Funded Grant Supplemental Agreement; and

WHEREAS, in Fiscal Year 2021, the Engineering Department budgeted for infrastructure projects as approved by the Board of County Commissioners in the Fiscal Year 2021 Budget; and

WHEREAS, the County, when preparing its budget for Fiscal Year 2021, did not anticipate receiving additional grant revenue from State of Florida's Department of Transportation related to the improvements to SR 313 at US 1; and

WHEREAS, recognizing and appropriating \$150,000.00 to the Engineering Capital Projects Department will allow payment of expenses related to this project; and

WHEREAS, entering into the Supplemental Agreement serves the interests of the County and the public.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AS FOLLOWS:

- Section 1. The above Recitals are incorporated by reference into the body of this Resolution, and such Recitals are adopted as findings of fact.
- Section 2. The Board of County Commissioners hereby approves the terms, conditions, provisions, and requirements of the State-Funded Grant Supplemental Agreement between the Florida Department of Transportation and St. Johns County, and authorizes the County Administrator, or designee, to execute the Supplemental Agreement on behalf of the County, in substantially the same form and format as attached.
- Section 3. The Board of County Commissioners recognizes and appropriates unanticipated revenue in the amount of \$150,000.00 into Transportation Trust Fund and authorizes its expenditure by the St. Johns County Engineering Capital Projects Department.
- Section 4. To the extent that there are typographical and/or administrative errors and/or omissions that do not change the tone, tenor, or content of this Resolution, this Resolution may be revised without subsequent approval of the Board of County Commissioners.
 - Section 5. This Resolution shall become effective immediately upon its adoption.
