

RESOLUTION NO. 2021 - 512

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO PURCHASE AND TO EXECUTE A PURCHASE ORDER FOR THE PURCHASE OF ONE (1) BRAUN CHIEF XL REMOUNT ON TO RAM 5500 4X2 CHASSIS, ONE (1) BRAUN SUPER CHIEF REMOUNT ON TO FREIGHTLINER CREW CAB CHASSIS, AND ONE (1) NEW BRAUN CHIEF ON RAM 5500 4X2 DIESEL CHASSIS AMBULANCE FROM TEN-8 FIRE EQUIPMENT, INC. FOR THE SJC FIRE RESCUE.

RECITALS

WHEREAS, the County seeks to purchase one (1) Braun Chief XL remount on to Ram 5500 4x2 Ambulance Chassis replace Rescue 21 CV #0162, one (1) Braun Super Chief remount to Freightliner Crew Cab Ambulance chassis to replace Rescue 18 CV #1735 and one (1) new Ambulance Braun Chief XL on Ram 5500 4X2 diesel chassis to replace Rescue 51 CV #1733; and

WHEREAS, in accordance with section 302.6.5.4 of the St. Johns County Purchasing Manual, entitled "Piggyback or Cooperative Purchasing," the County is authorized to make said purchase subject to the terms and conditions of the Florida Fire Chief's Association, Florida Sheriff's Association & Florida Association of Counties Contract #FSA20-VEF14.01 ("Contract"); and

WHEREAS, purchase of the equipment will be funded by the SJC Fire Rescue; and

WHEREAS, the County has reviewed the terms, provisions, conditions and requirements of the Contract as it has been competitively procured and is in accordance with St Johns County Purchasing policies, finds that piggybacking off the Contract for purchase of the ambulances serves a public purpose.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.

Section 2. The County Administrator, or designee, is hereby authorized to piggyback the Florida Fire Sheriff's Association Contract No. FSA20-VEF14.01 for the purchase of one (1) Braun Chief XL remount on to Ram 5500 4x2 Ambulance Chassis, one (1) Braun Super Chief remount to Freightliner Crew Cab Ambulance chassis, and one (1) new Ambulance Braun Chief XL on Ram 5500 4X2 diesel chassis;

Section 3. In accordance with the terms and conditions of the Contract, the County Administrator, or designee, is further authorized to execute a purchase order in the amount of \$850,612.00 to Ten-8 Fire Equipment, Inc. for the specified ambulances.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
