

RESOLUTION NO. 2021 - 513

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO PIGGYBACK THE FLORIDA DEPARTMENT OF MANAGEMENT SERVICES AGRICULTURE AND LAWN EQUIPMENT CONTRACT NO: 25101900-21-STC AND TO EXECUTE A PURCHASE ORDER FOR THE PURCHASE OF ONE (1) 2021 JOHN DEERE 6130M UTILITY TRACTOR.

RECITALS

WHEREAS, the County seeks to purchase one (1) 2021 John Deere 6130M Utility Tractor for the SJC Road and Bridge Department; and

WHEREAS, in accordance with section 302.6.5.4 of the St. Johns County Purchasing Manual, entitled "Piggyback or Cooperative Purchasing", the County is authorized to make said purchase subject to the terms and conditions of Florida Department of Management Services Agriculture and Lawn Equipment Contract #25101900-21-STC ("Contract"); and

WHEREAS, purchase of the equipment will be funded by the SJC Road and Bridge Department; and

WHEREAS, the County has reviewed the terms, provisions, conditions and requirements of the Contract and finds that entering into the Contract for purchase of the utility tractor serves a public purpose.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.

Section 2. The County Administrator, or designee, is hereby authorized to piggyback the Florida Department of Management Services Agriculture and Lawn Equipment Contract No: 25101900-21-STC for the purchase of one (1) 2021 John Deere Model 6130M Utility Tractor.

Section 3. In accordance with the terms and conditions of the Contract, the County Administrator, or designee, is further authorized to execute and issue a purchase order in the amount of \$104,420.63 to Ag-Pro of St. Augustine for the specified Utility Tractor.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
