

RESOLUTION NO. 2022- 288

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING AND ADOPTING THE ST. JOHNS COUNTY LOCAL MITIGATION STRATEGY PLAN, AS AMENDED TO INCLUDE A HISTORICAL FLOODING ANALYSIS TO MEET THE REQUIREMENTS OF THE NATIONAL FLOOD INSURANCE PROGRAM'S COMMUNITY RATING SYSTEM.

WHEREAS, St. Johns County, with more than 50 repetitive loss properties, is designated as a Category C repetitive loss community by the National Flood Insurance Program's (NFIP) Community Rating System (CRS); and

WHEREAS, Category C repetitive loss communities are required to prepare and adopt a Floodplain Management Plan that includes full credit for planning step 5(c), "Review of all damaged buildings/flood insurance claims," to maintain their class standing with the CRS program and eligibility for NFIP insurance; and

WHEREAS, the St. Johns County Local Mitigation Strategy serves as the County's Floodplain Management Plan; and

WHEREAS, St. Johns County has conducted a historical flooding and damage analysis to be included as Appendix I in the Local Mitigation Strategy Plan.

NOW, THEREFORE BE IT RESOLVED, by the Board of County Commissioners of St. Johns County, Florida that:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution, and such Recitals are adopted as Findings of Fact.


Section 2. The Board of County Commissioners hereby approves and adopts the Local Mitigation Strategy Plan, as amended and incorporated herein as Exhibit A.

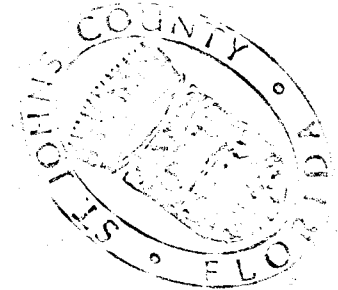




