

RESOLUTION NO. 2022-309

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR OR HIS DESIGNEE, TO EXECUTE FEDERAL TRANSIT ADMINISTRATION (FTA) GRANTS AND TO RECOGNIZE THE REVENUES IN THE 2022 FISCAL YEAR BUDGET FOR THE OPERATION AND PURCHASE OF VEHICLES FOR THE ST. JOHNS COUNTY PUBLIC TRANSPORTATION SYSTEM.**

**WHEREAS**, the Federal Transit Administration has been authorized under Chapter 53, Title 23 of the United States Code to award federal public transportation funding assistance; and

**WHEREAS**, St. Johns County seeks to submit a FFY 21/22 multi-sourced grant application to the FTA, seeking a Section 5307 Urbanized Area grant of \$3,383,726, a Section 5339(b) Bus and Bus Facilities Program grant of \$299,548, and FHWA transfer funds of \$500,000 for public transportation funding assistance; and

**WHEREAS**, the matching funds for Operating will come from a Florida Department of Transportation Block grant, and from the county general fund; and

**WHEREAS**, the matching funds for Capital items will come from the Florida Department of Transportation in the form of Transportation Development Credits; and

**WHEREAS**, this allocation is designated for operations and maintenance of the St Johns County public transportation system, and for the purchase of replacement buses; and

**WHEREAS**, these funds are referenced in the State Transportation Improvement Program reference numbers 406789-9, 441522-1, and

**WHEREAS**, to receive these funds a Federal Transit Administration grant must be submitted; and

**WHEREAS**, as required by FTA guidelines, the Board of County Commissioners of St. Johns County must conduct a public hearing to consider and approve a Program of Projects prior to application submittal to serve as the basis for the requested funding; and

**WHEREAS**, once approved by the Federal Transit Administration, the grant will be executed by St. Johns County; and the funding will be recognized in the county budget; and


**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:

1. The above recitals are incorporated by reference into the body of this resolution and such recitals are adopted as findings of fact.
2. The Board of County Commissioners hereby approves submission of the FFY 21/22 Section 5307/5339 and FHWA grant application and the revenues will be included in St Johns County's budget, and;
3. Upon approval of the application, the County Administrator, or designee, is hereby authorized to execute the grant agreement, along with any required supplemental documentation, on behalf of the County.

4. To the extent that there are typographical or administrative errors that do not change the tenor, tone or concept of this resolution, then this resolution may be revised without subsequent approval of the Board of County Commissioners.

St Johns County (6410) is a direct recipient of Section 5307 funds. This is a new application requesting funds apportioned to the St Augustine Area UZA; combining three funding sources: 5307, 5339, and SU/STP funds as follows:

FFY 2021-- Section 5307--1,025,850  
 FFY 2021--Section 5339-- 143,157:  
 FFY 2021-- FHWA SUSTP--250,000;

FFY 2022-- Section 5307 --1,558,328;  
 FFY 2022--Section 5339 -- 156,391:  
 FFY 2022-- FHWA SUSTP-- 250,000;

These funds will be used to assist the operation and maintenance of St Johns County's deviated fixed route and paratransit services. Capital funds will be used to cover eligible expenses for one year of operating costs, preventive maintenance, project administration, and bus replacements. This funding will permit the transit provider to meet preventive maintenance standards, continue to provide operations, and keep rolling stock in a state of good repair. Riders that rely on public transportation will benefit from continued service, permitting the workforce and individuals with physical disabilities to get to work, and to activities that are necessary for everyday living.

St Johns County does not anticipate the purchase of items over \$5,000 in value, other than the buses purchased from the state contract. Any items with value over \$5,000 identified during the execution of the activities under this ALI will be included via budget revision (actual value and useful life).
