

RESOLUTION NO. 2022-322

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING THE 2022-2023 NON-AD VALOREM ASSESSMENT ROLL AND ANNUAL ASSESSMENT RATE FOR THE MOULTRIE CROSSING LIFT STATION MUNICIPAL SERVICE BENEFIT UNIT AND AUTHORIZING THE CERTIFICATION OF SAID ASSESSMENT ROLL TO THE ST. JOHNS COUNTY TAX COLLECTOR BY THE CHAIRMAN OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA.

WHEREAS, the Board of County Commissioners of St. Johns County, Florida (**Board**) enacted Ordinance No. 2013-21 (**Ordinance**) on May 7, 2013, to provide for the creation of Municipal Service Benefit Units with associated non-ad valorem assessment rolls to fund certain utility line improvements to serve the real property located therein; and,

WHEREAS, the Board of County Commissioners of St. Johns County, Florida, adopted Resolution No. 2016-378 on December 6, 2016 to provide for the creation of the Moultrie Crossing Lift Station Municipal Service Benefit Unit (**MSBU**) with an associated non-ad valorem assessment roll to fund the retrofit and upgrade of the lift station to serve the real property located therein; and

WHEREAS, Florida Statute 197.3632 requires the Board to certify a non-ad valorem assessment roll on compatible electronic medium to the tax collector by September 15 of each year; and

WHEREAS, a Certificate to Non-ad Valorem Assessment Roll for 2022-2023, attached hereto as **Exhibit "A"**, incorporated by reference and made a part hereof, has been prepared to reflect the number of units and unit rate of the Moultrie Crossing Lift Station MSBU and to authorize the electronic transmission of the aforementioned Rolls to the St. Johns County Tax Collector.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above recitals are incorporated by reference into the body of this Resolution and such recitals are adopted as findings of fact.

Section 2. The assessment roll on file with the office of the Clerk for the MSBU included in the attached Certificate to Non-ad Valorem Assessment Roll is hereby approved and the Chair of the Board, or designee, is authorized to execute said Certification. Pursuant to Section 197.3632, Florida Statutes, the assessment roll shall be certified to the St. Johns County Tax Collector prior to September 15, 2022.

Section 3. Special assessments imposed within the assessment area listed on the roll in Section 2 hereof shall constitute a lien against assessed real property equal in rank and dignity with the liens of all state, county, district or municipal taxes and other non-ad valorem assessments. Except as otherwise provided by law, such lien shall be superior in dignity to all other liens, titles and claims, until the ad valorem tax bill for such year is otherwise paid in full pursuant to the Uniform Assessment Collection Act. The lien shall be deemed perfected upon adoption of this Resolution and shall attach to the real property included on such assessment rolls as of January 1, 2022, the lien date for ad valorem taxes.

Section 4. The Clerk of the Courts of St. Johns County is instructed to file the Certificate in the Public Records of St. Johns County, Florida.


Section 5. If any portion of this Resolution is for any reason held or declared to be unconstitutional, inoperative or void, such holding shall not affect the remaining portions this Resolution. If this Resolution or any provisions hereof shall be held to be inapplicable to any person, property or circumstances, such holding shall not affect its applicability to any other person, property or circumstances.

Section 6. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

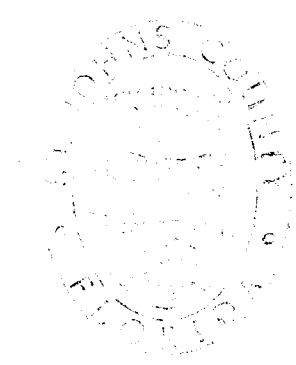

24 units are to be assessed \$768.00 per unit.

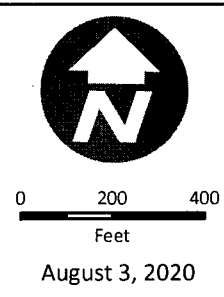
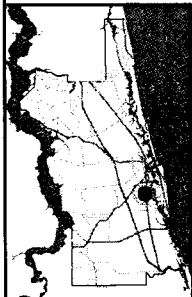
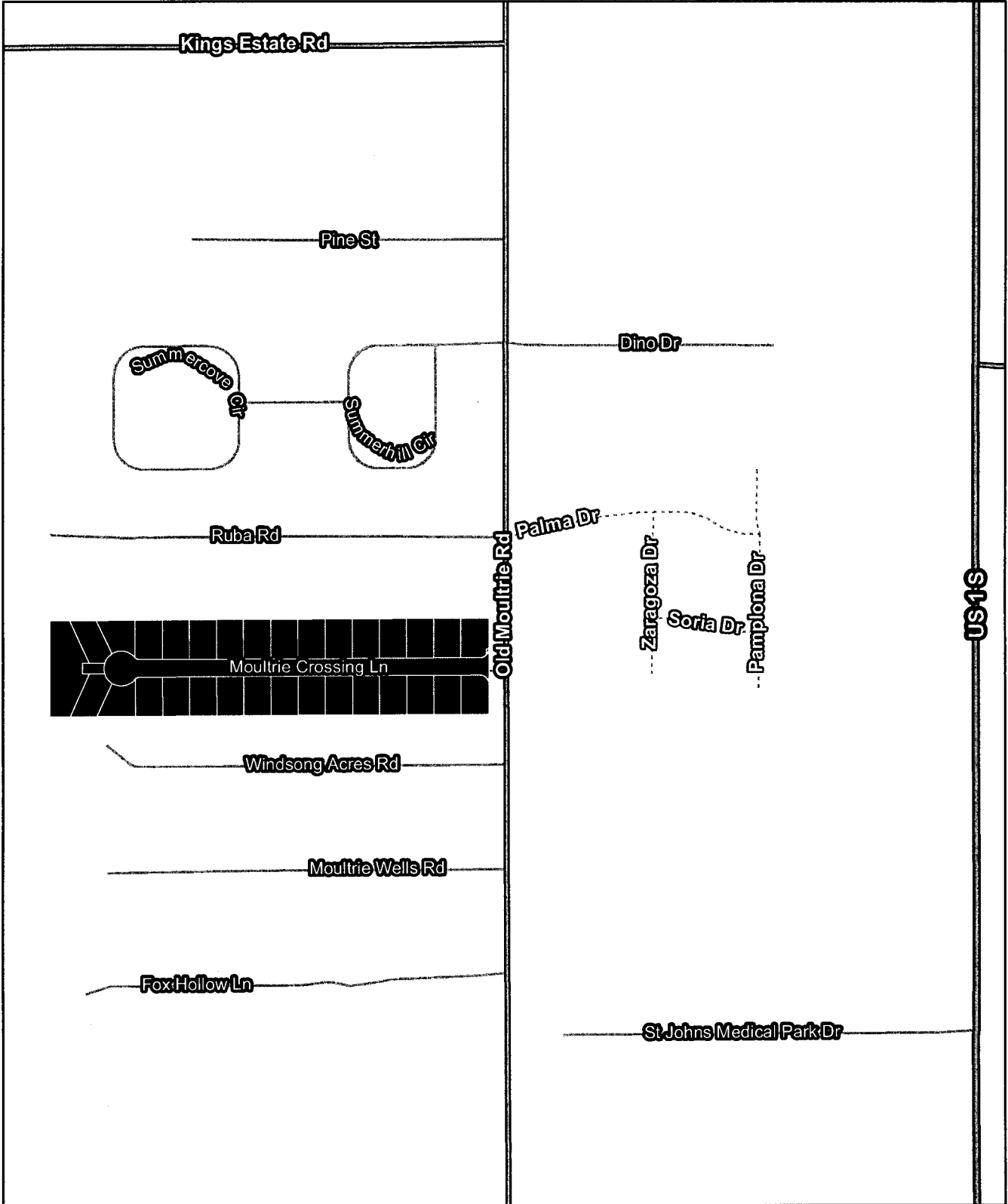
The Roll has been certified and is to be electronically transferred to the St. Johns County Tax Collectors Office by the County MIS Department.
