

RESOLUTION NO. 2022 - 61

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO EXECUTE A TASK ORDER WITH A.W.A. CONTRACTING CO., INC TO COMPLETE DRAINAGE REPAIRS ON J FLACK ROAD AS SPECIFIED UNDER BID NO. 18-14 (MASTER CONTRACT NO. 17-MCC-AWA-08972).

RECITALS

WHEREAS, On January 31, 2018, the County entered into a task order based continuing services contract with A.W.A. Contracting Co., Inc., which establishes terms and conditions and unit prices by which Countywide Roadway Drainage & Infrastructure Maintenance services shall be performed; and,

WHEREAS, the contract requires approval from the St. Johns County Board of County Commissioners for all task orders greater than \$200,000; and,

WHEREAS, drainage repairs are needed on J Flake Road, which falls within the scope of the contracts referenced above, and based upon the comparison of unit prices available under Bid No: 18-14, AWA Contracting Co., Inc has the lowest cost to complete the work at a not-to-exceed amount of \$209,109.93; and,

WHEREAS, the task order will be funded through the FY2022 Countywide Drainage Infrastructure; and,

WHEREAS, the County has reviewed the terms, provisions, conditions and requirements of the proposed task order (attached hereto, and incorporated herein) and finds that executing the task order to complete the work serves a public purpose; and,

WHEREAS, the task order will be in substantial conformance with the attached draft task order.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.

Section 2. The County Administrator, or designee, is hereby authorized to execute a task order for A.W.A. Contracting Co., Inc. to perform the required work for a not-to-exceed amount of \$209,109.93, in accordance with the Master Contract.

Section 3. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

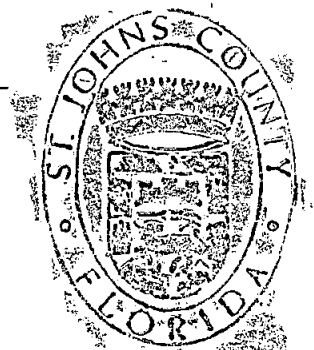

SCOPE OF WORK:

Task Order #88 is hereby issued to authorize A.W.A. Contracting Co., Inc. ("Contractor"), to provide all labor, equipment, and materials for drainage repairs on J Flake Road, as stated in the Contractor's proposal dated January 18, 2022, and attached hereto. The authorized work shall generally include the following tasks: MOT; erosion control; removal of existing asphalt, pipe, headwalls, and unclassified material; installation of new 10' x 5' Box Culvert and 24" Reinforced Concrete Pipe (RCP); back fill; place limerock; repair asphalt; dress shoulders; regrade ditches; and lay sod.

PAYMENT TERMS:

The County shall compensate the Contractor, under Task Order #88, a not-to-exceed amount of two hundred nine thousand one hundred nine dollars and ninety-three cents (\$209,109.93), based on unit prices, and actual quantities, for work satisfactorily completed in accordance with the provisions of this task order, and with the Master Contract dated January 31, 2018.

SCHEDULE:

The County shall issue a Notice to Proceed to the Contractor upon receipt of a recorded Public Construction Bond. Work shall commence by or before June 1, 2022 upon receipt of the Notice to Proceed and shall be completed on or before **September 20, 2022**. The Effective Date of this Task Order shall be the date of signature by an authorized St. Johns County Representative. Any work performed prior to full execution of this Task Order shall be at the Contractor's Own Risk.
