Α **RESOLUTION BY THE BOARD OF COUNTY** COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, **RECOGNIZING AND APPROPRIATING AN ADDITIONAL \$12,000 ALLOCATED TO THE COUNTY FROM FLORIDA** DIVISION OF EMERGENCY MANAGEMENT UNDER THE **URBAN SEARCH AND RESCUE GRANT PROGRAM:** APPROVING AND AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO EXECUTE AND **MODIFICATION** DELIVER Α TO THE **GRANT** AGREEMENT BETWEEN FLORIDA DIVISION OF EMERGENCY MANAGEMENT AND THE COUNTY.

RECITALS

WHEREAS, on January 16, 2023, the Board of County Commissioners recognized and appropriated an allocation of \$12,000 from Florida Division of Emergency Management ("FDEM"), under its Urban Search and Rescue Grant Program and approved and authorized a State-Funded Grant Agreement between the County and FDEM ("Grant Agreement") (Resolution 2023-16); and

WHEREAS, FDEM notified the County it was allocated an additional \$12,000 in grant funds, subject to the same terms and conditions as the original funds; and

WHEREAS, as a condition of receiving the additional funds, FDEM has requested modification to the Grant Agreement; and

WHEREAS, St. Johns County Fire Rescue will use the additional grant funds to purchase tools and equipment to improve and expand its urban search and rescue capabilities; and

WHEREAS, the grant opportunity was not anticipated when preparing the fiscal year 2022-2023 St. Johns County Fire Rescue budget.

NOW, THEREFORE, be it resolved by the St. Johns County Board of County Commissioners, that:

Section 1. The above recitals are hereby adopted as legislative findings of fact and incorporated herein.

Section 2. The additional \$12,000 allocated to the County from Florida Division of Emergency Management under the Urban Search and Rescue Grant Program is hereby recognized and appropriated to the St. Johns County Fire Rescue budget.

Section 3. There is hereby approved and the County Administrator or designee, is authorized to execute and deliver, on behalf of the County, the modification to the Grant Agreement between the County and Florida Division of Emergency Management, in substantially the same form as attached hereto.

Section 4. To the extent there are typographical errors that do not substantially change the tone, tenor or concept of this resolution, this resolution may be revised without subsequent approval by the Board of County Commissioners.
