## RESOLUTION NO. 2023 - 305

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2023 COUNTY CULTURAL EVENTS FUND BUDGET TO RECEIVE UNANTICIPATED REVENUE AND AUTHORIZE ITS EXPENDITURE BY THE ST. JOHNS COUNTY CULTURAL EVENTS DIVISION.

**WHEREAS,** St. Johns County has a Cultural Events Division which operates through a Special Revenue Fund budget funded primarily by the collection of fees; and

**WHEREAS**, it is projected that the County will receive revenues higher than anticipated for Fiscal Year 2023 events; and

WHEREAS, the projected amount is \$6,411,398; and

WHEREAS, St. Johns County, Florida, when preparing its budget for Fiscal Year 2023, did not anticipate such higher event revenues; and

WHEREAS, recognizing \$6,411,398 to increase the Cultural Events Fund budget will allow for appropriation of the funds to the Cultural Events Department for payment of expenses associated with Fiscal Year 2023 events.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:

- 1. The above recitals are hereby adopted as legislative findings of fact and incorporated herein.
- 2. The County Cultural Events Fund revenue and expenditure budgets shall be adjusted to account for unanticipated revenue in the amount of \$6,411,398 for Fiscal Year 2023.
- 3. Such funds shall be appropriated to the Cultural Events Department for payment of expenses associated with Fiscal Year 2023 events.
- 4. To the extent that there are scriveners, typographical or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
