RECITALS

- WHEREAS, the easement allows the County to modify a sidewalk that leads to a pedestrian crossing in connection with the proposed traffic signal at Preservation Trail and Town Plaza Avenue; and
- **WHEREAS**, it is in the best interest of the County to accept the Temporary Construction Easement for the health, safety and welfare of its citizens.
- **NOW, THEREFORE BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, as follows:
- Section 1. The above Recitals are incorporated in the body of this Resolution and such Recitals are adopted as finding of fact.
- Section 2. The Board of County Commissioners hereby accepts the Temporary Construction Easement for the purposes mentioned above.
- Section 3. The Clerk is instructed to record the original Temporary Construction Easement in the public records of St. Johns County, Florida.
- Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

WITNESSETH, that for and in consideration of the sum of \$10.00 and other valuable considerations, receipt and sufficiency of which is hereby acknowledged, the grantor hereby gives, grants, bargains and releases to the grantee, a Temporary Construction Easement to enter upon and use the grantor's property for the construction of pedestrian facilities improvements located in St. Johns County, Florida, described as follows:

That portion of Town Plaza Avenue as described in deed recorded in Official Records Book 3182, page 268, of the public records of St. Johns County, Florida, that lies north of Preservation Trail and south of Greendale Drive and Rinaldo Way.

It is understood and agreed by the parties hereto that the rights granted herein will be for 24 months after the execution of this Temporary Construction Easement to allow for the project to be bid out, awarded and start of construction.
