

RESOLUTION NO. 2024 -20

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO PIGGYBACK THE FLORIDA SHERIFF'S CONTRACT NO: FSA23-EQU21.0 AND TO EXECUTE A PURCHASE ORDER FOR THE PURCHASE OF ONE (1) NEW COMBINATION JET/VACUUM SEWER CLEANER FROM CONTAINER SYSTEMS & EQUIPMENT CO, INC. FOR THE SJC UTILITY DEPARTMENT.

RECITALS

WHEREAS, the SJC Utility Department budgeted for a new Sewer Combination Cleaner to be purchased in Fiscal Year 2024; and

WHEREAS, in accordance with section 6.2.13 of the St. Johns County Purchasing Manual, entitled "Cooperative Purchasing / Piggybacking", the County is authorized to make said purchase subject to the terms and conditions of Florida Sheriff's Contract #FSA23-EQU21.0 ("Contract"); and

WHEREAS, purchase of the equipment will be funded by the SJC Utility Department; and

WHEREAS, the County has reviewed the terms, provisions, conditions and requirements of the Contract and finds that entering into the Contract for the purchase serves a public purpose.

NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as finds of fact.

Section 2. The County Administrator, or designee, is hereby authorized to piggyback Florida Sheriff's Contract No. FSA23-EQU21.0 for the purchase of one (1) Vac-Con Sewer Combination Cleaner.

Section 3. In accordance with the terms and conditions of the Contract, the County Administrator, or designee, is further authorized to execute and issue a purchase order in the amount of \$519,794.00 to Container Systems & Equipment Co, Inc. the authorized dealer, for the specific truck.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

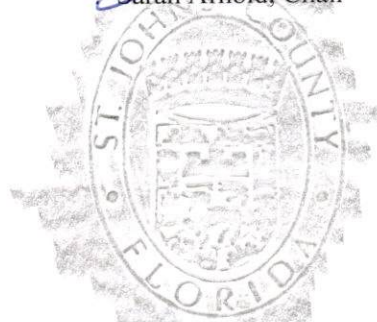
