WHEREAS, in current Fiscal Year 2024 Library Services has received unanticipated donations in the amount of \$ 2,870.84.

WHEREAS, the Library System seeks recognition of the total amount of donated funds \$ 2,870.84 as current year revenues to enable the appropriation of such funds for use.


NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:
