

RESOLUTION NO. 2024-285

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2024 TRANSPORTATION TRUST FUND AND IMPACT FEE ROADS ZONE B FUND BUDGET TO RECEIVE UNANTICIPATED DEVELOPER CONTRIBUTIONS REVENUE AND AUTHORIZE ITS EXPENDITURE BY THE ENGINEERING DEPARTMENT.

RECITALS

WHEREAS, in Fiscal Year 2024 the Engineering department budgeted for Capital Improvement Projects for CR 210 Widening – Greenbriar to Cimarrone, Woodlawn Road Improvements, and CR 210 Road Improvements from I-95 to US 1;

WHEREAS, the County, when preparing its budget for Fiscal Year 2024 did not anticipate receiving Developer Contributions for these Capital Improvement Projects; and

WHEREAS, the Developers have provided \$574,691.68 for CR 210 Widening – Greenbriar to Cimarrone, \$214,229.70 for Woodlawn Road Improvements and \$1,196,879.92 for CR 210 Road Improvements from I-95 to US 1; and

WHEREAS, recognizing and appropriating the \$1,771,571.60 to the Capital Projects department and \$214,229.70 to the Impact Fees Roads Zone B department will allow payment of expenses associated with these Capital Improvement Projects.

NOW, THEREFORE, be it resolved by the Board of County Commissioners of St. Johns County, Florida, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution, and such Recitals are adopted as findings of fact.

Section 2. The Transportation Trust Fund revenue and Capital Project department expenditure budgets shall be adjusted to account for unanticipated funds in the amount of \$1,771,571.60 and the Impact Fees Roads Zone B Fund and the Impact Fee Roads Zone B department expenditure budgets shall be adjusted to account for unanticipated funds in the amount of \$214,229.70.

Section 3. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
