

**RESOLUTION NO. 2024 - 322**

**A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2024 GENERAL FUND TO INCLUDE CERTAIN UNANTICIPATED REVENUE AND AUTHORIZE ITS EXPENDITURE BY THE LIBRARY SYSTEM.**

**RECITALS**

**WHEREAS**, the St. Johns County Fiscal Year 2024 operating budget was prepared prior to determining the total amount of grant revenue that would be received by the St. Johns County Public Library System (“Library System”); and

**WHEREAS**, the Fiscal Year 2024 budget included an estimated \$101,154 in State Aid to Libraries Grant; and

**WHEREAS**, in June 2024, the Library System received the State Aid to Libraries Notice of Grant Award in the amount of \$104,976; and

**WHEREAS**, the Library Services seeks recognition and appropriation of \$3,822 in State Aid to Libraries Grant as current year revenues to enable the appropriation of such funds for use.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, that:

1. The above recitals are hereby adopted as legislative findings of fact and incorporated herein.
2. The General Fund revenue and the Library System expenditure budgets shall be adjusted to account for unanticipated revenue in the amount of \$3,822.
3. To the extent, there are typographical and/or administrative errors and/or omissions that do not change the tone, tenor, or concept of this resolution, this resolution may be revised without subsequent approval by the Board of County Commissioners.

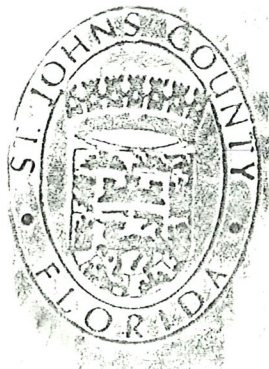
