JOHNS COUNTY SCHOOL DISTRICT APPROVE THE CONTINUATION OF THE DISCRETIONARY SALES SURTAX OF ONE-HALF CENT AS AUTHORIZED UNDER SECTION 212.055, FLORIDA STATUTES; PROVIDING FOR THE FORM OF THE BALLOT TITLE AND SUMMARY; PROVIDING FOR THE SCHOOL BOARD TO PUBLISH NOTICE OF THE REFERENDUM; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in 2015, the School Board of St. Johns County, Florida (the "School Board") determined that there was a need for construction of new school facilities, reconstruction and improvement of existing school facilities, and improvements in school safety, security and technology; and

WHEREAS, by 2015 the School Board determined, the capital outlay funding available to the School District of St. Johns County, Florida (the "District") had become insufficient for the cost of construction, reconstruction and improvement of public-school facilities, including safety and security improvements and technology upgrades; and

WHEREAS, Section 212.055(6), Florida Statutes, authorizes the imposition by school boards of a one-half cent sales surtax on all taxable transactions to fund capital outlay projects, subject to approval by the electors of the county voting in a referendum; and

WHEREAS, in November 2015, 60.81 percent of the electors of St. Johns County approved a one-half cent sales surtax to fund the cost of construction, reconstruction and improvement of public-school facilities within the District with an effective date of January 1, 2016; and

WHEREAS, since January 1, 2016, the District utilized the sales surtax proceeds to fund construction of new school facilities and the reconstruction and improvement of existing school facilities, including school safety and security improvements and technology upgrades; and

WHEREAS, the 2015 sales surtax is scheduled to expire December 31, 2025; and

WHEREAS, St. Johns County continues to experience significant population and publicschool enrollment growth; and WHEREAS, the St. Johns County School Board desires to submit to the qualified electors of St. Johns County the question as to whether or not to continuing the existing one-half cent sales surtax pursuant to Section 212.055, Florida Statutes, for the purpose of funding the costs of new construction, reconstruction,, and improvement of school facilities, including safety and security improvements and technology upgrades, with continued monitoring by the Sales Surtax Citizen Advisory Committee; and

WHEREAS, at a special meeting on August 20, 2024, the St. Johns County School Board duly adopted its Resolution 2024-05 calling for a referendum on the approval of continuing the existing one-half cent sales surtax, and pursuant to the specific authority of Section 212.055, Florida Statutes, calling for the Board of County Commissioners to place such question on the November 5, 2024, general election ballot ("the School Board Resolution"). A copy of the School Board Resolution is attached as *Appendix A*; and

WHEREAS, it is the Board of County Commissioners' statutory duty pursuant to Section 212.055, Florida Statutes to place on the referendum question as presented by the School Board Resolution, and to submit the question to the electors of St. Johns County on the November 5, 2024, general election ballot.

NOW THEREFORE BE IT RESOLVED AND ADOPTED by the Board of County Commissioners of St. Johns County, Florida:

- Section 1. <u>Authority for this Resolution</u>. This resolution is adopted pursuant to Sections 212.055, Florida Statutes, as amended, and other applicable provisions of law.
- Section 2. <u>School District Referendum</u>. The School Board Resolution shall be placed on the ballot of the general election on November 5, 2024, for submission to the electors of the St. Johns County School District.
- Section 3. <u>Ballot</u>. The form of ballot to be used shall be in substantially the following form:

The Superintendent of St. Johns County School District shall be responsible for placing a notice of the referendum in a newspaper of general circulation published in the District. The publication shall be made at least thirty (30) days prior to the referendum and shall be made at least twice, once in the fifth week and once in the third week prior to the week in which the referendum is deemed to be held. The notice of referendum shall be in substantially the form provided in the attached *Exhibit A*.

Section 5. <u>Places of Voting</u>; <u>Inspectors and Clerks</u>. The polls will be open at the voting places on the date and times of the General Election. All qualified electors residing within the District shall be entitled and permitted to vote at the referendum election on the proposition provided in the School Board Resolution. The places of voting and the inspectors and clerks of the referendum election shall be those designated by the Supervisor of Elections of St. Johns County in accordance with the law.

Section 6. <u>Vote-by-Mail</u>. Adequate provision shall be made by the Supervisor of Elections for voting by mail in accordance with the law. The form of ballots to be used in the referendum election for absentee voters shall be the same as used in the polling places for the election.

Section 7. <u>Early Voting.</u> Adequate provision shall be made by the Supervisor of Elections for early voting in accordance with the law. The form of ballots to be used in the referendum election for early voting shall be the same as used in the polling places for the election.

- Section 8. Printing of Ballots. Vote-by-mail, early voting and election day ballots are printed as necessary by the Supervisor of Elections of St. Johns County.
- Section 9. Referendum Election Procedure. The Supervisor of Elections of St. Johns County shall hold, administer, and conduct the referendum election in the manner prescribed by law for holding elections in the District. Returns shall show the number of qualified electors who voted at the referendum election on the proposition and the number of votes cast respectively for and against approval of the proposition. The returns shall be canvassed in accordance with law.
- Section 10. Severability. In the event that any word, phrase, clause, sentence, or paragraph of this Resolution shall be held invalid by any court of competent jurisdiction, such holding shall not affect any other word, clause, phrase, sentence, or paragraph.
- Repealing Clause. All Resolutions in conflict or inconsistent with this Section 11. Resolution are repealed insofar as there is conflict or inconsistency.
- Section 12. Effective Date. This Resolution shall take effect immediately upon its adoption.

A RESOLUTION OF THE SCHOOL BOARD OF ST. JOHNS COUNTY, FLORIDA, CALLING FOR A REFERENDUM TO BE HELD ON NOVEMBER 5, 2024, FOR THE PURPOSE OF SUBMITTING TO THE DULY QUALIFIED ELECTORS OF ST. **JOHNS** COUNTY, FLORIDA A OUESTION REGARDING THE CONTINUATION BY THE SCHOOL BOARD OF ST. JOHNS COUNTY, FLORIDA OF THE DISCRETIONARY SALES SURTAX OF ONE-HALF CENT FOR THE PURPOSE OF FUNDING THE COSTS OF NEW CONSTRUCTION, RECONSTRUCTION, AND IMPROVEMENT OF SCHOOL FACILITIES, INCLUDING SAFETY AND SECURITY IMPROVEMENTS AND UPGRADES. WITH CONTINUED TECHNOLOGY MONITORING BY THE SALES SURTAX CITIZEN ADVISORY COMMITTEE, AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, in 2015, the School Board of St. Johns County, Florida (the "School Board") determined that there was a need for construction of new school facilities, reconstruction and improvement of existing school facilities, and improvements in school safety, security and technology; and

WHEREAS, by 2015, the capital outlay funding available to the School District of St. Johns County, Florida (the "District") had become insufficient for the cost of construction, reconstruction and improvement of public school facilities, including safety and security improvements and technology upgrades; and

WHEREAS, Section 212.055(6), Florida Statutes, authorizes the imposition by school boards of a one-half cent sales surtax on all taxable transactions to fund capital outlay projects, subject to approval by the electors of the county voting in a referendum; and

WHEREAS, in November 2015, 60.81 percent of the electors of St. Johns County approved a one-half cent sales surtax to fund the cost of construction, reconstruction and improvement of public school facilities within the District with an effective date of January 1, 2016; and

WHEREAS, since January 1, 2016, the District utilized the sales surtax proceeds to fund construction of new school facilities and the reconstruction and improvement of existing school facilities, including school safety and security improvements and technology upgrades; and

WHEREAS, the 2015 sales surtax is scheduled to expire December 31, 2025; and

WHEREAS, St. Johns County continues to experience significant population and public school enrollment growth; and

WHEREAS, as of the beginning of the 2024-2025 school year, approximately 13,000 District students are scheduled to be housed in approximately 600 portable classrooms; and

WHEREAS, additional new schools and classroom additions are needed in St. Johns County to relieve overcrowding and reduce the need for portables due to enrollment growth; and

WHEREAS, school construction costs have significantly increased; and

WHEREAS, the need for the construction of additional new schools, reconstruction and improvement of existing schools and safety and security improvements and technology upgrades will continue indefinitely; and

WHEREAS, without an extension of one-half cent sales surtax, beginning in 2026, the District will lose more than \$35 million per year in capital outlay revenue, further impairing the District's ability to build and improve schools as necessary to properly serve St. Johns County students; and

WHEREAS, it is estimated that out of county visitors pay up to 38 percent of the sales taxes in St. Johns County; and

WHEREAS, pursuant to Section 212.055(6)(b), Florida Statutes, sales surtax revenue must now be shared with eligible charter schools based on their proportionate share of the total School District enrollment; and

WHEREAS, attached to this Resolution is a plan (the "Plan") consistent with the provisions of Section 212.055(6)(c), Florida Statutes, for the use of the proceeds of levy and collection of the surtax for capital outlay and technology implementation, including continued monitoring by the Sales Surtax Citizen Advisory Committee;

NOW, THEREFORE, BE IT RESOLVED BY THE SCHOOL BOARD OF ST. JOHNS COUNTY, FLORIDA THAT:

Section 1. Referendum. The School Board hereby calls for a referendum to be held throughout St. Johns County, Florida, on the Tuesday following the first Monday of November, which is November 5, 2024, for the purpose of submitting to the duly-qualified electors of St. Johns County the question of continuing the existing one-half cent sales surtax for the purpose of runding the costs of new construction, reconstruction, and improvement of school facilities, including safety and security improvements and technology upgrades, with continued monitoring by the Sales Surtax Citizen Advisory Committee. The School Board hereby requests for the St. Johns County Board of County Commissioners to: (i) approve the date for the referendum, and (ii) direct the St. Johns County Supervisor of Elections to place on the ballot the ballot question set forth in Section 9 below and conduct said election pursuant to the provisions of Florida's Election Code.

Section 2. <u>Term of Levy</u>. If approved by a majority of the ballots cast, the proposed surtax levy shall commence January 1, 2026. The surtax levy shall remain in full force and effect from January 1, 2026, until December 31, 2035, unless repealed or reduced prior to that time by resolution of the School Board, which repeal or reduction may be effectuated without referendum, so long as there are no bonds or other obligations of the School Board outstanding that are payable from the proceeds of such levy.

Section 3. <u>Administration</u>. The proposed surtax shall be collected, administered and paid to the School Board by the Department of Revenue pursuant to the terms of Section 212.054, Florida Statutes, and such other laws as may be applicable.

Section 4. <u>Plan for Use of Sales Surtax Proceeds</u>. The proceeds of the proposed school capital outlay sales surtax, as authorized by Section 212.055(6), Florida Statutes, shall be used to provide new construction, reconstruction and improvement of school facilities, including safety and security improvements and technology upgrades. A plan for these capital expenditures is set forth in the <u>Plan for Use of Sales Surtax Proceeds</u> which is attached hereto and incorporated herein as Exhibit A.

Section 5. <u>Charter Schools.</u> As required by Section 212.055(6)(b), Florida Statutes, sales surtax revenue will be shared with eligible charter schools based on their proportionate share of the total School District enrollment.

Section 6. <u>Sales Surtax Citizen Advisory Committee</u>. The existing St. Johns County School District Sales Surtax Citizen Advisory Committee shall continue to operate under its duly adopted Rules of Procedure as approved by the School Board of St. Johns County, Florida for the purpose of monitoring and advising the School Board in regard to the expenditure of the sales surtax proceeds.

Section 7. Operational Expenses. Neither the proceeds of the surtax nor any interest accrued thereto shall be used for operational expenses.

Section 8. Notice of Election. A notice of the referendum election shall be published in conformity with Florida law.

Section 9. Official Ballot. The official ballot to be used in the election to be held on Tuesday, November 5, 2024, shall be in English and Spanish and shall be in full compliance with the laws of the State of Florida and shall be substantially in the following form:
