RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, APPROVING A SUPPLEMENTAL AGREEMENT TO THE STATE-FUNDED AGREEMENT BETWEEN THE COUNTY AND FLORIDA DEPARTMENT OF TRANSPORTATION AMENDING THE PROJECT COMPLETION DATE FOR IMPROVEMENTS AT THE INTERSECTION OF SR 16 AT INTERNATIONAL GOLF PARKWAY TO DECEMBER 31, 2027; AUTHORIZING THE COUNTY ADMINSTRATOR, OR DESGINEE, TO EXECUTE THE SUPPLEMENTAL AGREEMENT ON BEHALF OF THE COUNTY.

WHEREAS, in Fiscal Year 2020 the County entered into a State-Funded Agreement with the Florida Department of Transportation for the funding of intersection improvements at SR 16 and International Golf Parkway; and

WHEREAS, it has become necessary to extend the project completion date from December 31, 2023 to December 31, 2027 due to the additional time needed to secure locations for stormwater retention ponds necessary for construction; and

WHEREAS, the extension of the deadline will allow for the completion of the required improvements and is in the interest of the County for the health, safety and welfare of its citizens.

**NOW THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, as follows:

Section 1. The above recitals are hereby adopted as legislative findings of fact and incorporated herein.

**Section 2.** The Board of County Commissioners of St. Johns County, Florida hereby approves the Supplemental Agreement between St. Johns County and Florida Department of Transportation, and authorizes the County Administrator, or designee, to execute the agreement on behalf of the County, in substantially the same form and format as attached hereto.

**Section 3**. To the extent there are typographical errors that do not substantively change the tone, tenor, or concept of this resolution, this Resolution may be revised without subsequent approval by the Board of County Commissioners.
