A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, ACCEPTING A DEED OF DEDICATION FROM MEMORIAL HEALTHCARE GROUP, INC., TO ST. JOHNS COUNTY DONATING PROPERTY FOR RIGHT-OF-WAY ALONG WOODLAWN ROAD FOR THE ROADWAY WIDENING PROJECT.

RECITALS

WHEREAS, Memorial Healthcare Group, Inc., a Florida Profit Corporation, has executed and presented to St. Johns County a Deed of Dedication for right-of-way, attached as Exhibit "A," incorporated by reference and made a part hereof, conveying additional right-of-way for the Woodlawn Road Widening project; and

WHEREAS, the owners are donating 17' of right-of-way without requesting any impact fee credits. The improvements include reconstructing a 2-lane major collector roadway with 12 foot travel lanes, paved shoulders, improved drainage and sidewalks from SR16 to White House Boulevard.

WHEREAS, it is in the best interest of the County to accept the Deed of Dedication for the health, safety and welfare of its citizens.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, as follows:

- **Section 1.** The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as findings of fact.
- **Section 2**. The Board of County Commissioners hereby accepts the Deed of Dedication for the purposes mentioned above.
- **Section 3.** To the extent that there are typographical errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.
 - Section 4. The Clerk is instructed to record the original Deed of Dedication in the Clerk's Office.




