RESOLUTION NO. 2024 - 422

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2025 FIRE DISTRICT FUND AND GENERAL FUND BUDGETS TO INCLUDE STAFFING FOR ADEQUATE FIRE AND EMERGENCY RESPONSE (SAFER) GRANT REVENUE AND TO APPROPRIATE SUCH REVENUE TO OFFSET THE COST OF FY 2025 SALARY AND BENEFITS FOR THE FLAGLER ESTATES FIRE STATION.

RECITALS

WHEREAS, the St. Johns County Fiscal Year 2025 operating budget was prepared prior to determining the total amount of grant revenue that would be received by the St. Johns County Fire Rescue and Emergency Medical Services Departments; and

WHEREAS, the Fiscal Year 2025 Fire Rescue and Emergency Medical Services department budgets include salaries and benefits for a total of 21 firefighters to staff the new Flagler Estates fire station; and

WHEREAS, on September 17, 2024, the Board approved a Staffing for Adequate Fire and Emergency Response (SAFER) Award grant award from the U.S. Department of Homeland Security Federal Emergency Management Agency ("DHS FEMA") in the amount of \$ 7,060,872.00 to cover the cost of salaries and benefits for three years for 21 firefighters at the new Flagler Estates Fire Station; and

WHEREAS the Fire Rescue and Emergency Medical Services departments seek recognition of DHS FEMA grant funds in the amount of \$1,881,997 as current year revenues and to enable the appropriation of such funds to reimburse the cost of FY 25 salaries and benefits.

NOW THEREFORE, BE IT RESOLVED by the Board of County Commissioners of St. Johns County, Florida, that:

- 1. The above recitals are hereby adopted as legislative findings of fact and incorporated herein.
- 2. The Fire District Fund and the Fire Rescue Transfers Department budgets shall be adjusted to account for unanticipated grant revenue in the amount of \$1,433,902.
- 3. The General Fund and the General Fund County Commission Reserve Department budgets shall be adjusted to account for unanticipated grant revenue in the amount of \$448,095.
- 4. To the extent, there are typographical and/or administrative errors and/or omissions that do not change the tone, tenor, or concept of this resolution, this resolution may be revised without subsequent approval by the Board of County Commissioners.
