A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. WHEREAS, per the requirements of Section 125.38, Florida Statutes, FDOT has made an application to the County to execute and deliver a Perpetual Easement, attached hereto as Exhibit "A", incorporated by reference and made a part hereof, conveying easement rights to FDOT, for a nominal fee. This project is for transportation purposes which are in the public or community interest and for public welfare and said request having been duly considered.

## NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above Recitals are incorporated by reference into the body of this Resolution and such Recitals are adopted as findings of fact.

Section 2. The Board of County Commissioners hereby authorizes the Chair of the Board, on behalf of the County, to execute and deliver to FDOT a Perpetual Easement, attached hereto.

Section 3. The Clerk is instructed to record the original Perpetual Easement in the public records of St. Johns County, Florida, and return the original Perpetual Easement along with a certified copy of this Resolution to the State of Florida Department of Transportation, 1109 South Marion Avenue, MS 2020, Lake City, Florida 32025-5874, Attention: Mindy Fletcher.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.






