

RESOLUTION NO. 2024-482

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, RECOGNIZING AND APPROPRIATING \$9,836.07 IN GRANT FUNDS FROM FIREHOUSE SUBS PUBLIC SAFETY FOUNDATION IN THE FY 2025 FIRE DISTRICT FUND BUDGET FOR THE PURCHASE OF PUBLIC SAFETY EQUIPMENT; AUTHORIZING THE COUNTY ADMINISTRATOR, OR DESIGNEE, TO EXECUTE DOCUMENTS NECESSARY TO ACCEPT AND IMPLEMENT THE AWARDED FUNDS

**RECITALS**

**WHEREAS**, Firehouse Subs Public Safety Foundation (the “Foundation”) administers a competitive grant program designed to provide lifesaving equipment and needed resources to first responders and public safety organizations to help them to better prepare to save lives in the communities they serve; and

**WHEREAS**, the County has been awarded \$9,836.07 in grant funding for the purchase of public safety equipment, including gas detection devices, calibration kits and bottles of calibration gas; and

**WHEREAS**, the Foundation administers the award through two procurement options, as determined by the Foundation, either a direct purchase of the equipment by the Foundation or a Memorandum of Understanding with the County to purchase the equipment; and

**WHEREAS**, the County did not anticipate receiving this funding during the Fiscal Year 2025 budget process and must appropriate these funds as unanticipated revenue.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida as follows:

**Section 1.** The above Recitals are hereby incorporated into the body of this Resolution and are adopted as findings of fact.

**Section 2.** The Board of County Commissioners hereby recognizes and appropriates \$9,836.07 in grant funding from Firehouse Subs Public Safety Foundation in the FY 2025 Fire District Fund budget for the purchase of public safety equipment; and authorizes the County Administrator, or designee, to execute any documents necessary to accept and implement the awarded funds.

**Section 3.** To the extent that there are typographical or administrative errors that do not change the tone, tenor, or concept of this resolution, this resolution may be revised without subsequent approval by the Board of County Commissioners.
