### **RESOLUTION NO. 2024 - 57**

RESOLUTION BYTHE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, DESIGNATING THE COMMERCIAL BUILDING LOCATED AT 165 VILANO ROAD (PARCEL ID 148120-0000), OWNED BY FISH HOUSE HOLDINGS, LLC, AS A LOCAL LANDMARK: PROVIDING FOR NOTIFICATION OF THE DESIGNATION: PROVIDING FOR INCLUSION OF THE LANDMARK DESIGNATION IN THE **CULTURAL** RESOURCE INVENTORY; PROVIDING FOR RECORDING THE LANDMARK DESIGNATION IN THE OFFICIAL RECORDS OF ST. JOHNS COUNTY.

## **RECITALS**

**WHEREAS**, the County enacted Section 3.01.03 of the Land Development Code ("LDC") to facilitate the designation of local landmarks, where appropriate; and

**WHEREAS**, the structure to be designated by this Resolution is the commercial building located at 165 Vilano Road (Parcel Id 148120-0000) (the "Property"), as requested and applied for by the property owner Fish House Holdings, LLC (the "Owner"); and

WHEREAS, the Property, known as the Barrancotto's Roma Restaurant, was originally constructed in the early 1950s and is a significant part of the Art Deco Streamline Moderne architecture in Vilano Beach; and

**WHEREAS**, the restaurant was family-owned and operated by the Barrancotto family until 2007 and was a vibrant business and contributor to the culture of Vilano Beach; and

WHEREAS, the structure represents the post-WWII growth of the area due to the development of motor courts, leading to an increase in the tourism industry as well as the architectural uniqueness of the Art Deco variation that became popular during the 1950's and 1960's and retains its sense of time and place as a small business constructed in the 1950s in a small coastal town; and

WHEREAS, pursuant to the requirements and criteria of LDC Section 3.01.03, the Board of County Commissioners has considered the issue of designating the Property as a local landmark, taking into consideration its importance and historical and cultural value, as more fully set forth in Designation Application LMA 2023-02 and Staff Report, both attached hereto; and

WHEREAS, all public notice and public hearing requirements have been met for designating the Property as a local landmark; and

- WHEREAS, on December 15, 2023, the St. Johns County Cultural Resource Review Board reviewed and recommended approval of the landmark designation; and
- WHEREAS, having met the requisite criteria, the Board finds that it is in the best interest of the citizens of the County to designate the Property as a local landmark, in furtherance of historic and cultural preservation and protection.
- **NOW, THEREFORE, BE IT RESOLVED** by the Board of County Commissioners of St. Johns County, Florida, as follows:
- **Section 1. Findings of Fact.** The above Recitals are hereby incorporated into the body of this Resolution, and are adopted as findings of fact.
- **Section 2. Designation of Local Landmark.** Pursuant to LDC Section 3.01.03, the Board hereby designates the Property located at 165 Vilano Road (Parcel Id 148120-0000) as a local landmark.
- **Section 3. Satisfaction of Requisite Criteria.** The Board finds that the Property achieved significance at least 50 years ago, meets at least three of the attributes of integrity and one or more of the requisite criteria set forth in LDC Section 3.01.03.C as more fully set forth in the Application and Staff Report. The attributes of integrity met are location, design, setting, and association; and the two criteria met are as follows:
  - 1. Exemplifies an historic, cultural, political, economic, or social trend of St. Johns County, the State of Florida, or the nation.
  - 2. Embodies distinguishing characteristics of an architectural style, period or method of Construction.
- **Section 4. Notice of Landmark Designation.** Pursuant to LDC Section 3.01.03.B.5, the Board directs the County Administrator, or designee, to notify the Owner and the adjacent property owners of the designation within fifteen (15) working days of the effective date of this Resolution.
- **Section 5.** Cultural Resource Inventory. Pursuant to LDC Section 3.01.03.B.6, the Board directs the County Administrator, or designee, to note this designation in the St. Johns County Cultural Recourse Inventory.
- **Section 6.** Recording of Landmark Designation. Pursuant to LDC Section 3.01.03.B.6, the Board directs the Clerk of Courts to record this Resolution in the official records for St. Johns County, Florida.
