

RESOLUTION NO. 2024-99

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, RECOGNIZING AND APPROPRIATING \$99,700 IN COMMUNITY DEVELOPMENT BLOCK GRANT DISASTER RECOVERY FUNDS, TITLED CDBG-DR; WITHIN THE FISCAL YEAR 2024 GENERAL FUND BUDGET IN ORDER TO COMPLETE CDBG-DR GRANT CLOSEOUT REQUIREMENTS.

RECITALS

WHEREAS, on February 20, 2018, The County entered into a federally funded CDBG-DR program subgrant agreement with the Florida Department of Economic Opportunity (DEO) to coordinate drainage infrastructure projects and reconstruction of homes damaged from Hurricanes Hermine and/or Matthew; and

WHEREAS, in FY 2023, the county planned to complete all the construction phase of the CDBG-DR Housing Program, and did not anticipate needing additional time to complete the Housing construction work; and

WHEREAS, DEO, renamed "Florida Department of Commerce", has authorized a contract extension through October 31, 2024 to all allow the County to expend remaining CDBG-DR grant award funding for grant closeout; and

WHEREAS, in order to complete the remaining Housing projects, the County must transfer \$99,700 from CDBG-DR Affordable Housing 0114-55304 to CDBG-DR Housing 0113-55304 within the Fiscal Year 2024 General Fund budget. Affordable housing projects have been completed. DEO has approved transferring the remaining affordable housing funds to cover the cost of finishing current housing rehabilitation projects.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY:

- 1.** The above recitals are incorporated by reference into the body of this resolution and such recitals are adopted as findings of fact.
- 2.** The Board of County Commissioners transfer \$99,700 from CDBG-DR Affordable Housing 0114-55304 to CDBG-DR Housing 0113-55304 within the Fiscal Year 2024 General Fund Budget.

3. To the extent that there are typographical or administrative errors or omissions that do not change the tone, tenor, or context of this resolution, this resolution may be revised without subsequent approval of the Board of County Commissioners.

4. This resolution shall become effective immediately upon adoption.
