A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AUTHORIZING THE CHAIR OF THE BOARD, ON BEHALF OF THE COUNTY, TO EXECUTE A TERMINATION AND VACATION OF TEMPORARY CONSTRUCTION EASEMENT.

#### RECITALS

WHEREAS, Maley Family Limited Partnership, ("Maley") executed and delivered to St. Johns County ("County") a Temporary Construction Easement ("TCE") dated December 30, 2020, and recorded in Official Records Book 5189, page 1881 over a portion of their property located adjacent to State Road 16 to allow for staging and construction during a utility project; and

WHEREAS, the Temporary Construction Easement terminated upon completion of the construction project and the owner has requested that the Board execute a termination of easement as it creates a cloud on the title; and

WHEREAS, the County acknowledges that the project at this location is complete and, at Maley's request, has agreed to execute a Termination and Vacation of Temporary Construction Easement, attached hereto as Exhibit "A", incorporated by reference and made a part hereof.

## NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

- Section 1. The above Recitals are incorporated into the body of this Resolution and such Recitals are adopted as findings of fact.
- Section 2. The Board of County Commissioners hereby authorizes the Chair to execute the Termination and Vacation of Temporary Construction Easement, in substantially the same form as attached hereto, on behalf of the County.
- Section 3. The Clerk is instructed to record the original Termination and Vacation of Temporary Construction Easement in the public records of St. Johns County, Florida.

Section 4. To the extent that there are typographical and/or administrative errors that do not change the tone, tenor, or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.


# TERMINATION AND VACATION OF TEMPORARY CONSTRUCTION EASEMENT
