## RECITALS

WHEREAS, the owners of property located along Pleasure Lane have executed and presented to the County, Grant of Easements, attached hereto as Exhibit "A" and Exhibit "B", incorporated by reference and made a part hereof; and

WHEREAS, the easements will allow the County to perform drainage improvements and future maintenance when necessary to an existing ditch that provides drainage for this area; and

**WHEREAS,** it is in the best interest of the County to accept the Grant of Easements for the health, safety and welfare of its citizens.

## NOW, THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, as follows:

Section 1. The above recitals are incorporated by reference into the body of this Resolution and such recitals are adopted as findings of fact.

Section 2. The Board of County Commissioners hereby accepts the Grant of Easements for the purposes mentioned above.

Section 3. To the extent that there are typographical, scriveners or administrative errors that <u>do not</u> change the tone, tenor or concept of this Resolution, then this Resolution may be revised without subsequent approval by the Board of County Commissioners.

Section 4. The Clerk of the Circuit Court is instructed to record the original Grant of Easements in the Public Records of St. Johns County, Florida.


