

RESOLUTION NO. 2026-256

A RESOLUTION BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AMENDING THE FISCAL YEAR 2026 TRANSPORTATION TRUST FUND BUDGET TO RECEIVE UNANTICIPATED REVENUE, AND AUTHORIZING ITS EXPENDITURE BY THE ENGINEERING CAPITAL PROJECTS DEPARTMENT.

WHEREAS, sections of roadway located in the Bartram Trail area, along North Bartram Trail, South Bartram Trail, and Kentucky Branch were damaged by hydraulic spills from FCC Environmental vehicles; and

WHEREAS, FCC Environmental, has agreed to reimburse the County an amount of \$39,500.00 for the damages caused by their vehicles; and

WHEREAS, the St. Johns County Fiscal Year 2026 Budget did not anticipate receiving insurance proceeds for the roadway repair to damaged roadways in the Bartram Trail area; and

WHEREAS, the Transportation Trust Fund seeks recognition of the insurance proceeds in the amount of \$39,500.00 as current year revenues to enable the appropriation of such funds for use; and

WHEREAS, with the addition of these funds the County will perform the needed repairs under the Pavement Management Program.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF ST. JOHNS COUNTY, FLORIDA, AS FOLLOWS:

Section 1. The above recitals are incorporated into the body of this Resolution and adopted as findings of fact.

Section 2. The Board of County Commissioners hereby recognizes and appropriates \$39,500.00 insurance proceeds as unanticipated revenue into the Transportation Trust Fund and authorizes its expenditure by the St. Johns County Engineering Capital Projects Department.

Section 3. To the extent that there are typographical and/or administrative errors and/or omissions that do not change the tone, tenor, or content of this Resolution, then this Resolution may be revised without subsequent approval of the Board of County Commissioners.

Section 4. This Resolution shall be effective upon adoption by the Board of County Commissioners.
