### NORTH COASTAL DESIGN REVIEW BOARD

The North Coastal Design Review Board was created by the County Commission in December 2000. The Board meets every second Wednesday, 4:00 p.m. in the Permit Center, 4040 Lewis Speedway. The North Coastal Design Review Board shall consist of five (5) regular members and two (2) alternate members. Members shall be appointed by the Board of County Commissioners and shall serve at the pleasure of the Board of County Commissioners. Appointees to the Design Review Board shall be qualified through the demonstration of special interest, experience, or education in design, architecture or history of the North Coastal Overlay community of the area encompassing the North Coastal Corridor Overlay District. At least one member will be required to be a registered architect, unless, there are no applicants are received with these qualifications after a reasonable search and at least one member will be required to have expertise in historic preservation and/or the architectural history of Florida, unless there are no applicants with these qualifications after a reasonable search is done. At least one member will own an active business within the District, and at least 2 members must live in or within one mile of the North Coastal District. Members shall be appointed to four (4) year terms. Each member is required to file Financial Disclosure with the Supervisor of Elections.




