##### **4. US Department of Treasury Emergency Rental Assistance Grant Program**

On December 21, 2020, Congress approved a \$2.3 trillion legislative package including a \$25 billion emergency rental assistance program authorized under the year-end COVID-19 Relief and Omnibus spending package. Under the legislation, counties with populations above 200,000 residents are eligible to receive direct payments from the U.S. Treasury. Per the National Association of Counties, the current appropriation estimate for St. Johns County totals \$7,929,906.
