#### Presenter: Calvin Britt, President of the Florida Association of the Deaf

1. Discussion Item - Accessibility Needs for the Deaf and Hard of Hearing Community. Presentation by Calvin Britt of SeaMe Systems. Currently, there are no emergency alert notification systems on beaches in Florida that provide immediate and on-demand information to the deaf and hard of hearing (DHH) community at public beaches during an emergency evacuation. Discuss information about the accessibility tools in public spaces such as beaches, public parks, etc. that may assist the deaf and hard-of-hearing community in the event of an emergency. Highlight a system similar to the Beach Emergency Evacuation Lights System (BEELS) at public beaches. BEELS is an emergency alert notification system that incorporates programmed audio loudspeakers and LED lights that provide real-time alerts on beaches for the general public and the deaf and hard-of-hearing community. The system alerts the public of shark sightings, lightning, rip currents, etc.
