A1. PRESENTATION ON PUBLIC TRANSPORTATION SERVICES BY THE ST. JOHNS COUNTY COUNCIL ON AGING. AS A RESULT OF A BOARD REQUEST THE CONTRACTED PUBLIC TRANSPORTATION PROVIDER, THE ST. JOHNS COUNTY COUNCIL ON AGING, WILL GIVE A PRESENTATION ON THE PUBLIC TRANSPORTATION SERVICES THEY PROVIDE TO ST. JOHNS COUNTY. THE PRESENTATION WILL OUTLINE WHAT SERVICES THE COUNTY RECEIVES AS A RESULT OF FUNDING PROVIDED BY THE COUNTY, INCLUDING DETAILS ON HOW MANY AND WHO RECEIVES THESE SERVICES

Gary L. Mackey, Transit Grant Specialist, introduced himself and Becky Yanni, Executive Director, St. Johns County Council on Aging (COA). Yanni gave a presentation on the transportation services that the COA provided to the County, including background information on The Sunshine Bus Company, the relationship between the County, grant money and services provided by the COA.

(9:22 a.m.) Ed Clark, Director of Transportation Services, St. Johns County Council on Aging, gave a PowerPoint presentation on the St. Johns County COA operations, including The Sunshine Bus Company vs. COA paratransit services. Clark referenced the 2014 Florida Transit Handbook, *Exhibit A*.

(9:41 a.m.) Yanni continued her presentation on future plans/goals of the COA, noting increased service requests and the need for a county-wide needs assessment.

(9:44 a.m.) Bennett spoke about a proposed change to the 2015 St. Johns County Legislative Action Plan: expansion of St. Johns County public transit system. She noted the proposed addition to the action plan would position the County to request funding for a county-wide needs assessment.

(9:45 a.m.) McClure questioned Yanni on the location of route maps for The Sunshine Bus Company, fixed bus stops, most utilized bus stop/areas, designated stops and shelters, and funding sources to extend services. He clarified the cost per passenger mile and noted the low cost for advertisement space.

(9:53 a.m.) Tom Reynolds, 880 A1A Beach Boulevard, referenced the Green Line Route, *Exhibit B*, and spoke in favor of adding a fixed route to the St. Augustine Beach Town Center and the St. Johns County Public Library: Southeast/ Administration Center.

(9:56 a.m.) Wanchick noted that The Sunshine Bus Company was a great example of a non-profit organization and local government working together to provide a service that typically a community wouldn't find provided by the private sector. (9:57 a.m.) Stevenson expressed her appreciation to the volunteers, Bennett spoke on the proactive services provided to the community, and McClure spoke on the economic benefits.

(9:59 a.m.) Soria entered the meeting.

The meeting recessed at 10:00 a.m. and reconvened at 10:07 a.m., with Cameron and Ross not in attendance.

DISTRICT 1

1. PUBLIC HEARING, COMPAMD 2014-07, DURBIN CREEK NATIONAL, LLC. THIS IS AN ADOPTION HEARING FOR COMPREHENSIVE PLAN AMENDMENT 2014-07, KNOWN AS DURBIN CREEK NATIONAL, LLC, TO CHANGE THE LAND USE DESIGNATION ON APPROXIMATELY FIVE ACRES OF LAND FROM RURAL/SILVICULTURE (R/S) TO INTENSIVE COMMERCIAL (IC); DESIGNATE THOSE FIVE ACRES PLUS AN ADDITIONAL APPROXIMATELY 1,619 ACRES OF LAND, FOR A TOTAL OF 1,624 ACRES, AS AN URBAN SERVICE AREA, PURSUANT TO SECTION 163.3164 (50), FLORIDA STATUTES; PROVIDE A TEXT POLICY ESTABLISHING THE GENERAL DEVELOPMENT RIGHTS FOR THE PROPERTY; AND ADOPT AN UPDATE TO THE CAPITAL IMPROVEMENT SCHEDULE. THE PROPERTY IS LOCATED ON THE SOUTH SIDE OF RACE TRACK ROAD AND EAST AND WEST OF I-95. THE PLANNING AND ZONING AGENCY RECOMMENDED APPROVAL, ON A VOTE OF 7-0, ON JANUARY 15, 2015. THE BOARD DISCUSSED THE ITEM JANUARY 20, 2015, AND CONTINUED THE HEARING TO FEBRUARY 3, 2015, FOR FINAL CONSIDERATION. THE ONLY MATERIAL CHANGED FROM JANUARY 20TH IS THE REVISED TEXT POLICY PRESENTED AT THE HEARING BY THE APPLICANT, WHICH SETS THE SCENIC EDGE AT 30' FOR THE PORTIONS OF THE SITE WITHIN THE NORTHWEST SECTOR. STAFF WILL CONTINUE TO WORK WITH THE APPLICANT TO POTENTIALLY REFINE THE LANGUAGE PRIOR TO THE FINAL HEARING

Proof of publication of the notice of public hearing on COMPAMD 2014-07, Durbin Creek Landing National, LLC, was received, having been published in *The St. Augustine Record* on December 31, 2014.

Suzanne Konchan, Director of Growth Management, gave a PowerPoint presentation. She presented details of the COMPAMD 2014-07, Durbin Creek National, LLC, including text policy revisions: 1) the site will be developed with a mixture of uses, 2) the Durbin Creek corridor (750' north of the centerline) would be redesignated Conservation by 2025, and 3) to allow 30' scenic edges, opposed to 75', for non-residential development. She also noted a second letter received from the St. Johns County School District, dated January 30, 2015, and State agency reviews.

(10:15 a.m.) Konchan also gave a PowerPoint presentation and presented details on the Durbin Creek National, LLC, Development Agreement (DEVAGREE 2014-01). She noted roadway improvement phasing modifications for phases 2 and 3 and the capped amount and period of the interest carry reimbursable through the tax increment, 25 years and prime + 5%, not to exceed 15%.

(10:20 a.m.) Soria reviewed the revised/red-lined Development Agreement and exhibits.

(10:24 a.m.) Konchan referenced a roadway improvement phasing modifications map, *Exhibit A*, and noted the red, yellow, blue, and green sections. McClure requested clarification on phasing modifications.

(10:30 a.m.) Soria reviewed the revised/red-lined Durbin Tax Increment Ordinance and the Roadway Capacity Charge Ordinance.

(10:34 a.m.) McCormack noted that Regular Agenda Items 1, 2, 3, and 4, were not quasi-judicial items.

(10:35 a.m.) Ellen Avery-Smith, Rogers Towers, 100 Whetstone Place, representing the applicant, highlighted the economic and transportation benefits to the County. She introduced Tony Robbins, Senior Planner with PROSSER, 13901 Sutton Park Drive South, Jacksonville, FL.

(10:38 a.m.) Robbins gave a PowerPoint presentation on Durbin Creek National. He reviewed the site location, Cummer Trust ownership, Ordinance No. 2008-68, remaining property after the transfer of development rights, regional transportation linkages, and State Road 9B Extension: Benefits.

(10:41 a.m.) Avery-Smith continued the PowerPoint presentation. She reviewed a proposed future land use map amendment, a proposed text amendment (mixed use opportunity), phasing, annual economic impact, roadway phasing, and school mitigation, including Section 163.3164(50), Florida Statutes, Urban Service Area; Capital Improvements Element (CIE) Policy H.1.2.1(H), and CIE Policy H.1.5.3(D). She also noted a proposed change/addition to Exhibit F of the ordinance: For residential units, mitigation for any impacts of such residential development upon school facilities shall ensure the availability of adequate school facilities in compliance with State Law, the Comprehensive Plan, and any other regulations, *Exhibit B*, and introduced T.R. Hainline, Jr., Rogers Towers, 1301 Riverplace Boulevard, Suite 1500, Jacksonville, Florida.

(10:51 a.m.) Hainline gave an overview of the proposed project goals.

(10:56 a.m.) Bennett asked Hainline if the applicant agreed to the proposed revisions, to which he responded yes. (10:56 a.m.) McClure and Hainline clarified the funding source for the Tax-Increment Financing (TIF) Ordinance and the Roadway Capacity Charge Ordinance.

(10:57 a.m.) Ellen Whitmer, 1178 Natures Hammock Road South, spoke in opposition of reducing the scenic edge and in opposition of the utility taxation from Jacksonville Electric Authority (JEA).

(10:59 a.m.) Tim Forson, St. Johns County School District, 40 Orange Street, presented St. Johns County School District Total State and Local Millage vs. Capital Improvement Millage (2014-2015) graphs, *Exhibit C*. Discussion ensued on student funding, funding State mandates, and school impacts.

(11:12 a.m.) Bennett questioned if legal interrupted the changes that were made to the Comprehensive Plan language to satisfy the requirements of State Law for designating the project an Urban Service Area (USA)

(11:16 a.m.) Motion by Stevenson, seconded by Morris, carried 5/0, to enact Ordinance No. 2015-4, known as COMPAMD 2014-07, Durbin Creek National, LLC, as presented with a revised Exhibit F, adopting findings of fact 1-3 to support the motion.

AN ORDINANCE OF THE COUNTY OF ST. JOHNS, STATE OF FLORIDA, REGARDING COMPREHENSIVE PLANNING; AMENDING THE 2025 ST. 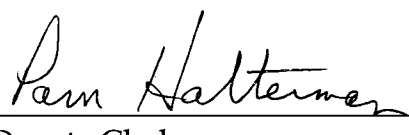
